**AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANSANG BLG. 257-2023 or ISANG ORDINANSANG NAGTATAG NG MGA PATAKARANG KAUGNAY SA PAGLALAKO NG MGA PANINDANG PAGKAIN SA MGA PAMPUBLIKONG LUGAR SA LUNGSOD NG BACOR AT NAGPAPATAW NG ANGKOP NA KAPARUSAHAN LABAN SA SINUMANG LALABAG NITO**

**WHEREAS**, the Sangguniang Panlungsod approved Ordinansa Blg. 257-2023 with the intent to allow only ambulant food vending that is clean, safe, and healthy for residents of Bacoor City to enjoy;

**WHEREAS**, the Ordinance regulates the selling of food and food products by ambulant vendors by ensuring that they are fully trained and capable to meet the basic standards of food safety and quality;

**WHEREAS**, the Local Government Code empowered the City Mayor to:

1. Enforce all laws and ordinances relative to the governance of the city and in the exercise of the appropriate corporate powers;
2. Issue licenses and permits and suspend or revoke the same for any violation of the conditions upon which said licenses or permits had been issued, pursuant to law or ordinance;
3. Issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

**NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacoor, Province of Cavite**, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations for Ordinansa Blg. 257-2023 herein attached.

**Section 1. Implementing Rules and Regulations (IRR).**

Attached herein is the Implementing Rules Regulations of Ordinansa Blg. 257-2023 which shall form part of this Executive Order. This shall be known as the "Implementing Rules and Regulations of Ordinansa Blg. 257-2023".

All affected offices and departments are hereby ordered to adopt the said implementing rules and regulations and be guided accordingly.

Strict compliance and observance of all city government officials and employees to this IRR is hereby ordered.

**THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANSA BLG. 257-2023

**RULE 1 – GENERAL PROVISIONS**

**SECTION 1. TITLE.**

These Implementing Rules and Regulations shall be known and cited as the "Implementing Rules and Regulations of ORDINANSA BLG. 257-2023 or the Ambulant Food Vending Ordinance of Bacoor."

**SECTION 2. PURPOSE.**

These Implementing Rules and Regulations are promulgated for the effective implementation and enforcement of ORDINANSA BLG. 257-2023.

**SECTION 3. CONSTRUCTION.**

The Implementing Rules and Regulations are promulgated for the effective Implementation and enforcement of ORDINANSA BLG. 257-2023.

**RULE 2. DECLARATION OF POLICY.**

**SECTION 4. It shall be the policy of the City of Bacoor:**

1. To ensure that the food and beverages available for consumption in the City of Bacoor are safe and healthy;
2. To further develop small and microbusiness in the City of Bacoor thru improvement of the quality of products and service of ambulant vendors.

**RULE 3. DEFINITION OF TERMS.**

**SECTION 5. The following terms shall be defined as follows:**

1. Ambulant Vendors – persons who sell their wares, products, food products, house to house or from one place to another.
2. Ambulant Vending Sanitation Permit – the Permit that is required to be applied for by the ambulant vendor and is issued by the City Health Office upon compliance with the rules and regulations set forth and the submission of appropriate and reasonable documentary requirements such as but not limited to health diagnostic results, chest x-rays, drug test results, stool exam results, and certificate of completion of training for food safety conducted by the City Government thru the relevant City Government Office, and the payment of fees.

3. Ambulant Vending Business Permit – the Permit that is required to be applied for by the ambulant vendor and is issued by the Bacoor Business Permit and Licensing Department upon the submission of the appropriate and reasonable documentary requirements such as but not limited to Barangay Certificate in case of an ambulant vendor who is a Bacoor City resident, Police Clearance, valid id, picture of products or items to be sold, and any certification from the company or manufacturer regarding the merchandise to be sold if available.

**RULE 4. MANDATORY GUIDELINES.**

**SECTION 6. REQUIREMENTS.**

Ambulant vendors are required to secure the following requisites in order to do business in the City of Bacoor:

1. An AMBULANT VENDING SANITATION PERMIT (AVSP) from the City Health Office.
  - a. The following are required before the issuance of the AVSP:
    - I. Chest X-ray;
    - II. Drug Test conducted by the City Health Office;
    - III. Stool Exam;
    - IV. Certificate of Completion of Training for Food and Safety conducted by the City Livelihood Office and City Health Office.
    - V. Receipt of Payment of FIFTY PESOS (PHP 50.00) for the AVSP fee to the City Treasurers Office.
2. An AMBULANT VENDING BUSINESS PERMIT(AVBP) from the Business Permit and Licensing Office
  - a. The following are required for the issuance of the AVBP:
    - I. Barangay Certificate (for Bacoor residents)
    - II. Police Clearance
    - III. Valid ID
    - IV. Pictures of products or items to be sold
    - V. If available, certification from the company or manufacturer, or producer regarding the merchandise to be sold.
    - VI. Receipt of Payment of ONE HUNDRED FIFTY PESOS (PHP150.00) for AVBP.

The fees must be paid before the last day of January for each year.

**SECTION 7. Cooperation of the Punong Barangay.**

The Punong Barangay of all Barangays in the City of Bacoor are hereby enjoined to render their full cooperation in the implementation of this Ordinance.

The City Health Office thru the designated Barangay Health Workers with the assistance of relative City Government Offices will conduct a seminar that is not more than sixteen (16) hours for clean and hygienic cooking, preparation, handling, preservation, packaging and selling of food and beverage.

An ambulant vendor who fails to attend the seminar above-described shall be considered in violation of the Ordinance.

**SECTION 8. Cooperation of City Government Offices.**

All relevant city government offices are hereby enjoined to render support and assistance to the execution of this Order as may be required in the exigency of public service or as ordered by the City Mayor.

**RULE 5. PENALTIES.**

**SECTION 8. PENALTIES.**

A violator of the Ordinance or this IRR will suffer the penalty of a fine of FIVE HUNDRED PESOS for each violation.

**RULE 6. MISCELLANEOUS PROVISIONS.**

**SECTION. 13. SEPARABILITY.**

In case certain provisions of this IRR are declared void by a court of law, the provisions hereof not affected by the said judicial declaration shall continue to have legal force and effect.

**SECTION 14. EFFECTIVITY.**

This IRR shall take effect immediately.
