**EXECUTIVE ORDER NO. 36-2023
SERIES OF 2023**

AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS OF CITY ORDINANCE NO. 262-2023 or AN ORDINANCE PROHIBITING THE SALE, DISTRIBUTION, POSSESSION AND DRINKING OF ALL ACOHOLIC BEVERAGES IN ALL PUBLIC PLACES WITHIN THE CITY OF BACOR, CAVITE FROM 10:00 PM TO 5:00 AM, ORDERING THE CLOSURE OF BARS AND BEER HOUSES SELLING ALCOHOLIC BEVERAGES BY 12:00 AM, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF

WHEREAS, the Sangguniang Panlungsod approved City Ordinance No. 262-2023 with the intent to safeguard the public from excessive and harmful alcohol drinking and to preserve the order and peace in the City Government of Bacoor;

WHERAS, the Ordinance regulates the selling of alcoholic beverages within the territorial jurisdiction of the City of Bacoor;

WHEREAS, the Local Government Code empowered the City Mayor to:

1. Enforce all laws and ordinances relative to the governance of the city and in the exercise of the appropriate corporate powers;
2. Issue licenses and permits and suspend or revoke the same for any violation of the conditions upon which said licenses or permits had been issued, pursuant to law or ordinance;
3. Issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;

NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacoor, Cavite, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations for City Ordinance No. 262-2023 herein attached.

Section 1. Implementing Rules and Regulations (IRR).

Attached herein in the Implementing Rules Regulation of City Ordinance No. 262-2023 which shall form part of this Executive Order. This shall be known as the "Implementing Rules and Regulations of City Ordinance No. 262-2023".

All affected offices and departments are hereby ordered to adopt the said implementing rules and regulations and be guided accordingly.

Strict compliance and observance of all city government officials and employees to this IRR is hereby ordered.

Section 2. Repealing Clause.

All previously issued orders and directives inconsistent with any provision found herein shall be deemed repealed, revoked, or amended accordingly.

Section 3. Separability Clause.

In the event that any provision found herein be judicially or administratively declared illegal or infirm, the remaining provisions shall remain in full force and effect.

Section 4. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect until repealed, revoked or amended accordingly.

THE IMPLEMENTING RULES AND REGULATION OF CITY ORDINANCE NO. 262 – 2023 OR AN ORDINANCE PROHIBITING THE SALE, DISTRIBUTION, POSSESSION AND DRINKING OF ALL ACOHOLIC BEVERAGES IN ALL PUBLIC PLACES WITHIN THE CITY OF BACOR, CAVITE FROM 10:00 PM TO 5:00 AM, ORDERING THE CLOSURE OF BARS AND BEER HOUSES SELLING ALCOHOLIC BEVERAGES BY 12:00 AM, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

RULE 1 – GENERAL PROVISIONS

SECTION 1. TITLE.

These Implementing Rules and Regulations shall be known and cited as the "Implementing Rules and Regulations of City Ordinance No. 262-2023 or the Liquor Sale Regulation Ordinance of Bacoor".

SECTION 2. PURPOSE.

These Implementing Rules and Regulations are promulgated for the effective implementation and enforcement of City Ordinance No. 262-2023.

SECTION 3. CONSTRUCTION.

The Implementing Rules and Regulations are promulgated for the effective implementation and enforcement of City Ordinance No. 262-2023.

RULE 2 – DECLARATION OF POLICY

SECTION 4.

It shall be the policy of the City of Bacoor that there be paramount consideration for the safety, security, and wellbeing of Bacoor Residents while they are traversing our city roads, streets, and thoroughfares.

SECTION 5. Definition of Terms.

1. **Alcoholic Beverages** – all beverages containing ethanol such as beer, wine, whisky, and distilled spirits, the consumption of which produces intoxication, or otherwise increases the blood alcohol content of those who consume said beverages.
2. **Business Establishments** – a place where commercial activities are conducted which shall include but not shall not be limited to the sale of various alcoholic beverages whether or not the said enterprise possess or does not possess a valid business permit issued by the Business Permit and Licensing Department.
3. **Sale** – the exchange of an alcoholic beverage for money or for any consideration.

4. Distribution – the sharing or supplying of alcoholic beverages from one place to another including the delivery of such products from outside of the territorial jurisdiction of the City of Bacoor to a place within the said City.
5. Possession – the carrying of an alcoholic beverage – regardless of its quantity – by any person including the transportation of such beverages in a motor vehicle.
6. Drinking – the consumption of alcoholic beverages in a motor vehicle.
7. Public Places – any place outside one's residence including any place where three or more people are invited, welcomed, convinces, or encouraged to enter for the purpose of consuming alcoholic beverages of any type or quantity.

RULE 4. MANDATORY GUIDELINES.

1. The sale, distribution, possession, and drinking of all alcoholic beverages by all business establishments and in all public places within the City of Bacoor, Cavite is hereby prohibited from 10:00 PM to 5:00 AM every day.
2. All night clubs and beer houses and other similar establishments selling alcoholic beverages within the City of Bacoor shall not allow the sale of the said products beyond 10:00 PM. The operation of the night clubs, beer houses or similar establishments selling alcoholic beverages shall cease at 12:00 AM.

However, the selling of food products and non-alcoholic beverages within the said night clubs, beer houses and other similar establishments may continue even beyond 12:00 AM.

RULE 5. PENALTIES.

1. All business establishments that will violate this Ordinance shall be administratively closed for fifteen (15) to forty-five (45) calendar days upon the finding of a violation by the City Government of Bacoor.
2. The owner, manager, or supervisor of the said establishments including the person/s who actually sold, distributed, possessed, or drank the intoxicating beverages during the prohibition period mentioned above **shall pay an administrative fine of PHP5,000.00, and shall be imprisoned for thirty (30) days** upon conviction by a court of competent jurisdiction.
3. In case the offender qualifies for the rendition of community service in lieu of paying the said fines or serving the said imprisonment pursuant to City Ordinance No. 228-2022 (the Uniform Procedures Implementation Ordinance of Bacoor) the payment of the said fines and the serving of the said imprisonment may be suspended.
4. In case the offender is an employee of the city government, the said person may – aside from being made to pay the fines and to serve the prison terms mentioned above – also be terminated from employment pursuant to pertinent civil service rules and regulations.

5. In case the offender is a corporation, or partnership, the president CEO or managing partner of the said juridical entity shall pay the appropriate fines and shall serve the prison terms imposed by the court after conviction.
6. No criminal action shall be filed in court by any official/employee of the city government unless an Ordinance Violation Receipt is issued against the offender/s pursuant to the relevant provisions of City Ordinance No. 228-2022.
7. In case of a repeat offender, his or her business permit shall be cancelled pursuant to Section 128 (3) of City Ordinance No. 2013-060 or the 2013 Revenue Code of the City of Bacoor.

RULE 5. MISCELLANEOUS PROVISIONS.

SECTION 6. SEPARABILITY.

In case certain provisions of this IRR are declared void by a court of law, the provisions hereof not affected by the said judicial declaration shall continue to have legal force and effect.

SECTION 7. EFFECTIVITY.

This IRR shall take effect immediately.
