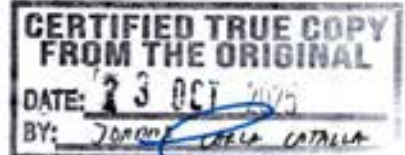

EXECUTIVE ORDER No. 11 - 2024

**AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS
OF CITY ORDINANCE NO. 319-2023, OTHERWISE KNOWN AS THE
"LIBRENG SINE ORDINANCE OF BACOOR"**

WHEREAS, Section 16 of Republic Act No. 7160 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Republic Act ("R.A.") No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010" provides for a twenty percent (20%) discount privilege to senior citizens on admission fees in cinema houses, among other privileges;

WHEREAS, Republic Act ("R.A.") No. 10754, otherwise known as "An Act Expanding the Benefits and Privileges of Persons with Disability", provides for a twenty percent (20%) discount privilege to persons with disabilities on admission fees in cinema houses, among other privileges;

WHEREAS, the Sangguniang Panlungsod passed City Ordinance No. 24-2014 ("An ordinance Granting a Free Movie privilege to all Bacoor Senior and Disabled Citizens 2014"), a social service legislation intended for the benefit of senior citizens and persons with disabilities on September 04, 2014;

WHEREAS, the Sangguniang Panlungsod passed City Ordinance No. 29-2019 ("An Ordinance Amending Section 2 and Section 3 of City Ordinance 24-2014, as amended by City Ordinance No. 29-2019;

NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacoor, Cavite, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations of City Ordinance No. 319-2023 herein attached.

Section 1. Implementing Rules and Regulations (IRR).

Attached herein is the Implementing Rules and Regulations of City Ordinance No. 319-2023 which shall form part of this Executive Order. This shall be known as the "Implementing Rules and Regulations of the Libreng Sine Ordinance of Bacoor".

All affected offices and departments are hereby ordered to adopt the said implementing rules and regulations and be guided accordingly.

Strict compliance and observance of this IRR by all city government officials and employees is hereby ordered.

Section 2. Repealing Clause. All previously issued orders and directives inconsistent with any provision found herein shall be deemed repealed, revoked or amended accordingly.

Section 3. Separability Clause. In the event that any provision found herein shall be judicially or administratively declared illegal or infirm, the remaining provisions shall remain in full force and effect.

Section 4. Effectivity Clause. This Executive Order shall take effect immediately upon its signing and remain in full force and effect until repealed, revoked or amended accordingly.

**IMPLEMENTING RULES AND REGULATIONS
OF CITY ORDINANCE NO. 391-2023, SERIES OF 2023**

OR

**"AN ORDINANCE FURTHER AMENDING CITY ORDINANCE NO.
24-2014 SERIES OF 2014 ("AN ORDINANCE GRANTING A FREE
MOVIE PRIVILEGE TO ALL BACOR SENIOR AND DISABLED
CITIZENS IN RELATION TO CITY ORDINANCE NO. 29-2019,
SERIES OF 2019**

The LIBRENG SINE PROGRAM is one of the different social privileges the City Government of Bacoor provides to its constituents, particularly for senior citizens and persons with disabilities. It is an inspiring project of Hon. Strike B. Revilla, in coordination with cinema operators, aiming to grant additional privileges to all resident senior citizens and persons with disabilities and let them enjoy the rest of their lifetime, thereby increasing their quality of life.

**RULE I
GENERAL PROVISIONS**

SECTION 1. TITLE – These Implementing Rules and Regulations shall be known and cited as the "Implementing Rules and Regulations of City Ordinance No. 391-2023 SERIES OF 2023"

SECTION 2. PURPOSE – These Implementing Guidelines prescribe the guiding framework and procedures for effectively implementing the Libreng Sine Program to expedite compliance.

SECTION 3. LEGAL BASIS –

1. Section 5, Article II of the 1987 Philippine Constitution declares that promoting the general welfare is "essential for the enjoyment by all the people of the blessings of democracy."

4. **Senior Citizens** – refers to any resident citizen of the Philippines, particularly with the City Government of Bacoor for purposes of this Guidelines, who is at least sixty (60) years old;
5. **Special Beneficiaries** – refers to other beneficiaries of the Libreng Sine Program, apart from the Senior Citizens and Persons with Disability.
6. **Special Events** – refers to occasions or events celebrated within the City Government of Bacoor where the Libreng Sine Program may be implemented.

RULE III

COVERAGE

SECTION 5. BENEFICIARIES – The clientele of this Program are the following:

1. Qualified Senior Citizens who are bona fide residents of the City of Bacoor, Province of Cavite, as evidenced by their Senior Citizens Affair Identification Card; and
2. Qualified Persons with Disabilities who are residents of the City of Bacoor, Province of Cavite, as evidenced by their Persons with Disabilities Identification Card.

SECTION 6. TERMS AND CONDITIONS. – The terms and conditions of this Libreng Sine Program are as follows:

1. Each client may watch one (1) movie per day, at any time for Monday Screenings only;
2. Each Senior Citizen and Person with a Disability may avail of the Libreng Sine privilege once (1) per week;
3. The number of beneficiaries of this Program is capped at one thousand (1,000) beneficiaries per Free Screening Day. However, the number of beneficiaries may exceed the maximum capped with the consent of both Parties;

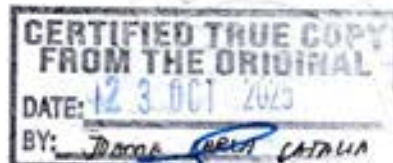


4. The partner cinema operator shall accommodate the Senior Citizen or Person with a Disability who is unable to present their respective Senior Citizen and PWD IDs as long as they are able to present their Special Residence Bacoor (SBR) Card stating that they are indeed residents of the City of Bacoor.
5. The Libreng Sine Program will apply only to 2D movie screenings and regular movie screenings. The Beneficiaries may NOT avail of the privilege in any of the following instances:
 - a. Special screening (i.e., premier night, red carpet/VIP screenings, advance screenings, live broadcast of sporting events, and the like);
 - b. Special events and/or live shows held at the SM Cinemas;
 - c. Movie screenings during the annual 2-week Metro Manila Film Festival;
 - d. Newly released movies covering that week and
 - e. Other analogous instances
6. This privilege shall not apply or be extended to companions of Beneficiaries who are not qualified resident senior citizens or persons with disabilities themselves;

SECTION 7. POWER OF THE CITY MAYOR TO SUSPEND SBR CARD OR ACKNOWLEDGMENT RECEIPT. The requirement for an SBR Card or an Acknowledgement Receipt to avail the benefits of the Libreng Sine Program may be suspended solely and exclusively upon the written order of the City Mayor of Bacoor.

SECTION 8. LIBRENG SINE PROGRAM CUT-OFF. Senior citizens and persons with disability may avail of the benefits of the Libreng Sine Program on or before 5:00 PM. No other beneficiaries shall be allowed to avail beyond 5:00 PM for safety and security purposes.





SECTION 9. SPECIAL BENEFICIARIES. – The Beneficiaries of the Libreng Sine Program may be extended to different classes or groups of individuals who are residents of the City of Bacoor in celebration or commemoration of any national or local events, subject to availability of funds, as may be determined and approved by the City Government of Bacoor and qualified cinema operator, subject to the following terms and conditions;

1. The Special Beneficiaries, excluding Senior Citizens and Persons with Disabilities, are entitled to the benefits of this Program only once (1) per year. The City Mayor of Bacoor has the sole authority to identify who are these Special Beneficiaries.
2. The Special Beneficiaries need to present their SBR Card or an Acknowledgment Receipt that they applied for an SBR Card to avail of the Libreng Sine Program.
3. Each Special Beneficiary is entitled to the privilege of this Program on the following dates only:
 - a. Bacoor Cityhood Anniversary is celebrated every June 23 of each year;
 - b. Bakood Festival is celebrated every last Sunday of each year;
 - c. Birthday Celebration of our City Mayor, Hon. Strike B. Revilla, every March 2 of each year;
 - d. Plebiscite celebration to be commemorated every July 29 of each year.
4. The above enumeration is not exclusive. The City Government may notify the cinema operator in case it desires to include other Special Events subject to further discussion and approval of both parties.
5. The maximum number of beneficiaries per Special Event as above enumerated is capped at one thousand (1000) Special Beneficiaries only. However, the Parties may agree to increase the number of Special Beneficiaries in excess of the target attendees, subject to the approval of both Parties.

6. The City Government of Bacoor shall notify the cinema operator in writing at least thirty (30) days before the intended program implementation date.

RULE IV PROOF OF DOCUMENTATION OF ELIGIBILITY

SECTION 10. PROOF. Each beneficiary of the Libreng Sine Program is required to present their valid SBR Cards, or in the absence thereof, the Acknowledgement Receipt indicating that the beneficiary applied and registered for an SBR Card to the attended City personnel ("Ticket Verifier") before the grant of free admission to the pertinent SM Cinema branch:

1. To prevent any anomaly and irregularity in the availment/enjoyment of the privilege, the City shall furnish the cinema operator with the official list containing the names, ID numbers, and specimen signatures of all qualified Beneficiaries (the "Master List"). The Master List must be updated on a quarterly basis by the. Nonetheless, the cinema operator shall not be obliged to look beyond the contents of the prevailing Master List when confirming the eligibility of a particular Beneficiary to the privilege set out hereunder. An SBR Card, or an Acknowledgement Receipt, shall be presumed to be valid if it is the same in form and substance.
 - A. The Ticker Verifier shall check and verify the SBR Card or Acknowledgement Receipt of the free cinema beneficiaries;
 - B. During verification, the Ticket Verifier shall input the details of the beneficiary in their respective Booklet.
 - C. Once verified, the Ticket Verified shall advise the beneficiary to proceed with the Ticketing Booth to secure their free cinema ticket from the Ticket Seller.
2. An availment movie booklet ("Booklet") issued and provided by the City Government of Bacoor to the beneficiaries. The Booklet shall be presumed to be valid if it is the same in form and substance with the following information specifically appearing thereon:

- A. Date of Availment;
 - B. Cinema Operator;
 - C. Cinema Number;
 - D. Title of the film to be viewed;
 - E. Stub Reference Number of Ticket Number; and
 - F. Signature of the Ticket Verifier
3. Once verified, the Ticketing Verifier shall issue a "**Libreng Sine Stub**" to the Beneficiary containing the (i) reference number, (ii) date, and (iii) signature of the Ticketing Verifier. The Libreng Sine Stub shall be presented by the Beneficiary to the attending cinema operator Ticketing Attendant ("Ticket Seller") before said Beneficiary is granted free admission to the cinema.
 4. The Ticket Verifier shall be assigned to a designated booth near the cinema.

RULE V COST APPORTIONMENT AND BILLING

SECTION 11. NET ADMISSION PRICE – For and in consideration of the privilege granted to the Beneficiaries, the City Government of Bacoor agrees to shoulder the Fifty percent (50%) Net Admission Price (or the 50% of the movie admission ticket price of the pertinent cinema operator tickets issued to Beneficiaries after the deduction of the mandatory 20% discount imposed by RA 9984 for senior citizens or RA 10754 for persons with disabilities thereon) of the movie tickets issued to the Beneficiaries. The remaining portion of the ticket price will be in the form of a discount granted by SM.

Gross	Php300.00
Less 20% Discount (for Senior Citizens or Persons with Disability)	60.00
Net Admission After Tax and 20% Discount	240.00
50% Cinema Operator's discount	120.00
50% City Government of Bacoor's share	120.00

SECTION 12. WAIVER OF AMUSEMENT TAX – The City Government of Bacoor hereby grants exemption from payment of amusement tax, which may be due to the allocation of the eighty percent (80%) discount between the parties.

The LGU BACOR shall pay the monthly Total Net Admission Price through set off from the Amusement Tax for remittance by the cinema operator to the City Government of Bacoor. Within the first twenty (20) calendar days of each month, the cinema operator shall promptly generate and provide to the City Government of Bacoor:

- an Audited report indicating the Total Net Admission Price from all **SM Cinema** tickets issued to Beneficiaries during the immediately preceding month (the "Billing Period"); and
- a proper statement of account (SOA) for said amount.

In the event that the gross Amusement Tax for remittance by the cinema operator to the local government in paragraph b above is lower than the City Government of Bacoor Share in paragraph of this Agreement, the cinema operator shall bill the City Government of Bacoor for the difference and shall issue within the first five (5) days of the current month, a proper SOA for said amount.

The City Government of Bacoor shall, within thirty (30) calendar days from receipt of a particular SOA, promptly and completely settle the amount due therein by releasing to the cinema operator or any of its duly authorized representatives the SOA itself together with a validly issued check representing the full payment of the amount due for the particular Billing Period. In case of failure of the City Government of Bacoor to timely release the check and/or settle the amounts under the SOA, which are due to the cinema operator for a period not exceeding sixty (60) days from receipt of respective SOA, the cinema operator shall have the right (but without being considered in default of its

obligations under this Agreement) to temporarily suspend the operation of the free movies for senior citizens program until full payment of the outstanding amount by the City Government of Bacoor.

RULE VI OBLIGATION OF THE PARTIES

SECTION 13. OBLIGATIONS OF THE CITY GOVERNMENT OF BACOOR – The City Government of Bacoor shall:

1. Furnish the cinema operator with the Master List;
2. Update the Master List on a quarterly basis;
3. Maintain accurate records in the implementation of the Libreng Sine Program;
4. Designate a focal person task in checking the validity and genuineness of the requirements of the Beneficiaries and
5. Provide the proper identification card and free Booklet to qualified Beneficiaries.

SECTION 14. OBLIGATIONS OF THE CINEMA OPERATOR – The cinema operator shall:

1. Allow Beneficiaries to enter the cinema upon proper verification of qualification, subject to the conditions of this IRR and the Memorandum of Agreement entered into by it to the City Government of Bacoor;
2. Submit to the City Government of Bacoor, within the first twenty (20) days of the succeeding month, the list of Beneficiaries who availed of the privilege together with the schedule of the gross receipts derived from the operation of the cinema for purposes of computing the amount of amusement tax due from which the cost of the privilege is to be deducted; and

3. Maintain accurate records in the implementation of the Libreng Sine Program.

RULE VII FINAL PROVISIONS

SECTION 15. SEPARABILITY CLAUSE – If, for any reason or reasons, any provision in this Implementing Guidelines is declared invalid or unconstitutional by a court of competent jurisdiction, the remaining parts thereof not affected shall continue to be in force and effect.

SECTION 16. EFFECTIVITY CLAUSE – This Implementing Guidelines shall take effect immediately upon its approval.
