**AN ORDER ADOPTING THE IMPLEMENTING RULES AND
REGULATIONS OF CITY ORDINANCE NO. 176-2021, SERIES OF 2021,
OTHERWISE KNOWN AS THE "ANTI-FIRECRACKER ORDINANCE OF
THE CITY OF BACOR"**

WHEREAS, Section 16 of Republic Act No. 7160 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Sangguniang Panlungsod enacted and passed City Ordinance No. 176-2021, Series of 2021 on 13 September 2021, entitled "*An Ordinance Banning The Use, Sale, Manufacture, And Distribution Of All Types Of Firecrackers Within The City Of Bacor And Providing Penalties For Violations Hereof,*"

WHEREAS, the City Government of Bacor recognizes the need to issue an Implementing Rules and Regulations pertinent to the above-mentioned Ordinance;

WHEREAS, the Office of the City Mayor of Bacor, in coordination with the concerned city government offices, issued the above-mentioned Implementing Rules and Regulations that shall govern the "*Anti-Firecracker Ordinance Of The City Of Bacor,*"

NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacor, Cavite, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations of City Ordinance No. 176-2021 herein attached.

Section 1. Implementing Rules and Regulations (IRR).

Attached herein is the Implementing Rules and Regulations of City Ordinance No. 176-2021 which shall form part of this Executive Order. This shall be known as the "**Implementing Rules and Regulations of Anti-Firecracker Ordinance Of The City Of Bacor.**"

**THE IMPLEMENTING RULES AND REGULATIONS
OF CITY ORDINANCE NO. 176-2021, Series of 2021**

"AN ORDINANCE BANNING THE USE, SALE, MANUFACTURE, AND DISTRIBUTION OF ALL TYPES OF FIRECRACKERS WITHIN THE CITY OF BACOOR AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF."

RULE I - GENERAL PROVISIONS

SECTION 1. TITLE. These Implementing Rules and Regulations shall be known and cited as the **"Implementing Rules and Regulations of City Ordinance No. 176-2021, Series of 2021 ("IRR")**, the **"ANTI-FIRECRACKER ORDINANCE OF THE CITY OF BACOOR."**

SECTION 2. PURPOSE. These Implementing Rules and Regulations are promulgated to prescribe a framework for effectively implementing and enforcing City Ordinance No. 176-2021, Series of 2021.

SECTION 3. CONSTRUCTION. The Implementing Rules and Regulations shall be construed and applied in compliance with and in furtherance of the policies and objectives of the above Ordinance.

RULE II – POLICIES AND OBJECTIVES

SECTION 4. DECLARATION OF POLICY. It shall be the policy of the City of Bacoor to promote the health and safety of its residents and constituents, maintain peace and order, and preserve the comfort and convenience of the inhabitants within the City of Bacoor.

RULE III – SCOPE AND COVERAGE

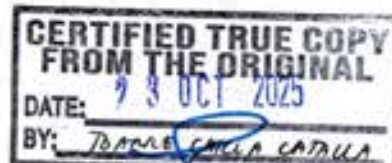
SECTION 5. COVERAGE. This Implementing Rules and Regulations shall only apply to the use, sale, manufacture, storage and distribution of all types of firecrackers within the City of Bacoor.

RULE IV - DEFINITION OF TERMS

SECTION 6. DEFINITION OF TERMS. For purposes of this Implementing Rules and Regulations, these terms are defined as follows:

1. **Firecrackers** – refer to explosive pyrotechnic devices primarily designed to produce a large amount of noise, colorful displays, or cracking sounds such as *rebentador*, *plapla*, *bawang*, *watusi*, *fountain*, *centurion ni Hudas*, *ahas*, *whistle bomb*, *Milano*, *goodbye world*, and *grumpily*.
2. **Fireworks** – refers to a class of explosive pyrotechnic devices used for aesthetic, cultural, and religious purposes.
3. **Distribution** – the circulation, supply, or dispersal of any type of firecracker, regardless of whether it was done for profit.
4. **Manufacture** – refers to the active participation of private citizens residing in the City of Bacoor in disaster response and management activities in response to a call to action from the city government.
5. **Sale** – is the trading, dealing, or vending of any type of firecracker within the City of Bacoor regardless of quantity; and.
6. **Use** – refers to the utilization of any type of firecracker regardless of whether or not the said product actually exploded while being used or turned out to be defective.
7. **Storage** – refers to the possession and/or safekeeping of firecrackers in any quantity.

Words used in the plural sense shall include the singular and vice versa. Words referring to the masculine gender shall include the feminine gender and vice versa.

RULE V – MANDATORY GUIDELINES

SECTION 7. PROHIBITION ON THE USE, SALE, MANUFACTURE, POSSESSION, AND DISTRIBUTION OF FIRECRACKERS. The City of Bacoor hereby prohibits the use, sale, manufacture, storage, and distribution of all types of firecrackers within its territorial jurisdiction.

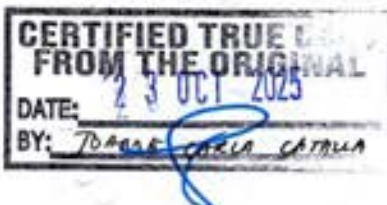

SECTION 8. REGULATED FIREWORKS DISPLAY. Fireworks displays during the celebration of special public occasions such as fiestas, Chinese New Year, Christmas, and New Year's Eve shall be allowed, provided that such celebrations shall only be performed by the city government at a venue chosen by it. The organizing committees of town fiestas or religious celebrations may also hold fireworks displays provided that they first obtain a Mayor's Permit at least seven (7) days prior to the date of the said celebration.

Public safety shall be the paramount concern in the holding of such fireworks displays. Only juridical entities duly licensed by the national government or by one of its agencies may take charge of such fireworks displays. Firework displays during the celebration of weddings, birthdays, graduations, or any similar personal milestones or achievements shall not be allowed.

SECTION 9. PUBLIC INFORMATION CAMPAIGN. The Public Information Office (PIO), under the Office of the City Mayor, shall launch an intensive public information campaign regarding the implementation of City Ordinance No. 176-2021, Series of 2021.

RULE VI – PENALTIES AND SANCTIONS

SECTION 10. PENALTIES. The following penalties shall be imposed against any person who violates City Ordinance No. 176-2021, Series of 2021:

A. FOR USING AND/OR POSSESSING FIRECRACKERS

PROHIBITED ACT	PENALTY
For using and/or possessing firecrackers	Fine of Php3,000.00 and the immediate destruction of the firecrackers in the possession of the offender at the time of his arrest

1. The destruction of the said firecrackers shall be done by immersing the said firecrackers in water. *Provided* that none of the firecrackers found in the possession of the offender shall be confiscated or stored because of serious safety risks. *Provided further* that the said firecrackers shall be weighed and photographed for evidentiary purposes before they are destroyed.

2. If the ***offender is a minor*** - the parents or guardians of the said offender shall be held liable to pay the said fine and shall be held liable for violating the pertinent provisions of Republic Act No. 7610 (also known as the "Child Abuse Act").
3. ***In case a minor residing within the City of Bacoar is injured or dies for using a firecracker within city limits*** - the parents or guardians of the said offender shall be held liable to pay the said fine and shall be held liable for violating the pertinent provisions of Republic Act No. 7610 (also known as the "Child Abuse Act").

B. FOR SELLING AND DISTRIBUTING FIRECRACKERS

PROHIBITED ACT	PENALTY
For selling and distributing firecrackers	Fine of Php5,000.00 and immediate destruction of the firecrackers in the possession of the offender at the time of his arrest.
Owners of industrial, institutional, commercial, or agricultural establishments that violate City Ordinance No. 176-2021, Series of 2021	Fine of Php5,000.00 and the business permit of the said establishment shall be cancelled

1. The destruction of the said firecrackers shall be done by immersing the said firecrackers in water. ***Provided*** that none of the firecrackers found in the offender's possession shall be confiscated or stored because of serious safety risks. ***Provided further*** that the said firecrackers shall be weighed and photographed for evidentiary purposes before they are destroyed.
2. If the ***offender is a minor*** - the parents or guardians of the said offender shall be held liable to pay the said fine and shall be held liable for violating the pertinent provisions of Republic Act No. 7610 (also known as the "Child Abuse Act").
3. In case ***minors are found to be working at the said establishments at the time that enforcers entered it while implementing City Ordinance No. 176-2021, Series of 2021*** - the

owners of the said establishments, as well as the parents of the said minors shall be held accountable for violation of the pertinent provisions of RA 7610 and of this Ordinance.

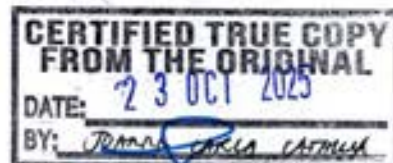
4. If the *violation is committed by a business establishment owned or operated by a corporation or partnership* - the President, General Manager, or any other person acting on behalf of either the President or General Manager shall be held liable.
5. If the *violation is committed by a business establishment owned or operated by a sole proprietorship* - the owner or the person acting on his behalf shall be held responsible for the said offense.

C. FOR MANUFACTURING FIRECRACKERS

PROHIBITED ACT/OFFENDER	PENALTY
For manufacturing firecrackers	Fine of Php5,000.00 and immediate destruction of the firecrackers found in the premises of the plant or factory at the time of apprehension.
Owners of industrial, institutional, commercial, or agricultural establishments that violate City Ordinance No. 176-2021, Series of 2021	Fine of Php5,000.00 and the business permit of the said establishment shall be cancelled

1. The destruction of the said firecrackers shall be done by immersing the said firecrackers in water. **Provided** that none of the firecrackers found in the offender's possession shall be confiscated or stored because of serious safety risks. **Provided further** that the said firecrackers shall be weighed and photographed for evidentiary purposes before they are destroyed.
2. In case *minors are found to be working at the said establishments at the time that enforcers entered it while implementing City Ordinance No. 176-2021, Series of 2021* - the owners of the said establishments, as well as the parents of the





said minors shall be held accountable for violation of the pertinent provisions of RA 7610 and of this Ordinance.

3. If the *violation is committed by a business establishment owned or operated by a corporation or partnership* - the President, General Manager, or any other person acting on behalf of either the President or General Manager shall be held liable.
4. If the *violation is committed by a business establishment owned or operated by a sole proprietorship* - the owner or the person acting on his behalf shall be held responsible for the said offense.

SECTION 11. COMMUNITY SERVICE IN LIEU OF IMPRISONMENT. Due to the health risks posed by COVID-19, which are aggravated when inmates are incarcerated in overcrowded detention centers, persons found convicted by a court of law for violating this Ordinance shall not be imprisoned but shall be required to render community service pursuant to the provisions of Republic Act No. 11362 (the "Community Service Act") and its implementing guidelines while the City of Bacoor is under quarantine or while its detention centers are overcrowded.

After completing the community service, the head of the concerned department/unit shall render a report to the office of the City Inspection and Compliance Unit, which shall consider the case closed. Non-completion of the community service as certified by the concerned department/unit head shall be deemed a waiver on the part of the violator to still avail of the benefits provided in this Ordinance, and the filing of the case with the City Prosecutor's Office shall proceed accordingly.

In the performance of community service, the offender shall not be made to perform any task that exposes him/her to public ridicule or bodily injury, or that requires him/her to do anything that can be characterized as cruel and unusual punishment.

RULE VII - MISCELLANEOUS PROVISIONS

SECTION 12. MANDATORY REVIEW. The Sangguniang Panlungsod shall review City Ordinance No. 176-2021, Series of 2021, and its implementing rules once every two (2) years following its effectivity date.

SECTION 13. SEPARABILITY CLAUSE. If, for any reason, any provision or part of this IRR is declared invalid or unconstitutional, other provisions not affected thereby shall remain in full force and effect.

SECTION 14. REPEALING CLAUSE. All Ordinances, Resolutions, local, Executive Orders, or Administrative Issuances or parts inconsistent with the IRR's provisions are hereby repealed, amended, or modified accordingly.

SECTION 15. EFFECTIVITY. This IRR shall take effect immediately.

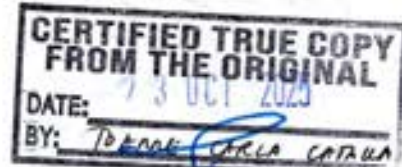

**AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS
OF CITY ORDINANCE NO. 244-2022, OTHERWISE KNOWN AS
THE "CALIBRATED TRICYCLE DEPLOYMENT ORDINANCE
OF THE CITY OF BACOOR"**

WHEREAS, Section 16 of R.A. No. 7160 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare including the promotion of safety of its constituents and provision of adequate transportation facilities;

WHEREAS, the Sangguniang Panlungsod enacted and passed City Ordinance No. 244-2022, otherwise known as the "Calibrated Tricycle Deployment Ordinance of the City of Bacoor" which authorizes the calibrated deployment of public utility tricycles (PUT) on special lanes along Molino-Paliparan Road and Tirona Highway subject to strict compliance by the tricycle drivers and operators concerned to the guidelines prescribed therein;

WHEREAS, the City Government of Bacoor recognizes the need to issue an Implementing Rules and Regulations pertinent to the above-mentioned Ordinance;

WHEREAS, the Office of the City Mayor of Bacoor, in coordination with the concerned city government offices, issued the above-mentioned Implementing Rules and Regulations that shall govern the "Calibrated Tricycle Deployment Ordinance";

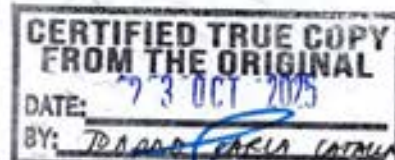

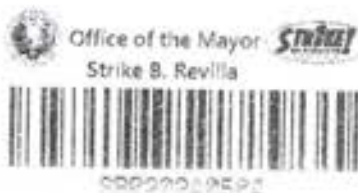

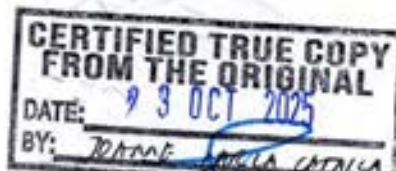

IMPLEMENTING RULES AND REGULATIONS
OF CITY ORDINANCE NO. 244-2022

AN ORDINANCE ALLOWING THE CALIBRATED DEPLOYMENT OF PUBLIC UTILITY TRICYCLES ON A SPECIAL LANE ALONG MOLINO-PALIPARAN ROAD AND TIRONA HIGHWAY IN BACOR CITY, CAVITE, AND IMPOSING PENALTIES FOR VIOLATIONS HEREOF.

RULE I
GENERAL PROVISIONS

Section 1. TITLE. These Rules shall be known and cited as the "Implementing Rules and Regulations of the Calibrated Tricycle Deployment Ordinance of the City of Bacor, Cavite".

Section 2. PURPOSE. These Rules and Regulations are promulgated to prescribe the procedures and guidelines for the effective implementation of Bacor City Ordinance No. 244-2022 governing the calibrated deployment of public utility tricycles (PUT) on a special lane in Molino-Paliparan Road and the Tirona Highway subject to strict compliance by the tricycle drivers and operators concerned.

Section 3. SCOPE AND APPLICATION. The provisions of these Rules shall also apply to tricycle drivers and operators affected by implementing and enforcing the Calibrated Tricycle Deployment Ordinance of the City of Bacor.

Section 4. IMPLEMENTING OFFICE. The Office of the City Mayor, in conjunction with the Bacor Traffic Management Department, shall be the lead office for implementing the Calibrated Tricycle Deployment Ordinance of the City of Bacor. As may be directed by the City Mayor, other city government departments, units, or offices shall assist in effectively implementing the Ordinance and this IRR.

RULE II
DECLARATION OF POLICY

Section 5. DECLARATION OF POLICY. It is the policy of the City Government of Bacor to:

1. Enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.





2. Recognize the integral role of the tricycle sector in the public transportation system in the City of Bacoor;
3. Protect and serve the best interest of the riding public and the tricycle sector by providing them with adequate and timely social and economic services under strict deployment and enforcement conditions provided herein;
4. Develop and promote small businesses and the local economy through maximizing the contribution of the tricycle sector;
6. Ensure the safety and protection of the riding public and tricycle drivers/operators.

RULE III DEFINITION OF TERMS

Section 6. DEFINITION OF TERMS. As used in these Rules, the following terms shall mean:

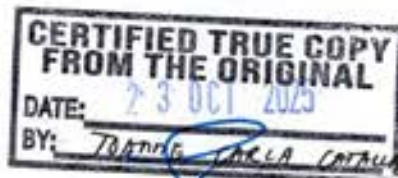
1. **Calibrated Deployment** - the BTMD policy will allow a limited number of public utility tricycles to transport passengers on the roads covered by the Calibrated Tricycle Deployment Ordinance.
2. **Global Positioning System** - a satellite-based radio navigation system used in communications, transportation, and other activities.
3. **Public Utility Tricycles (PUT)** are three-wheeled motor vehicles granted a franchise by the city government to operate as public utility vehicles on certain public roads within the City of Bacoor, Cavite.
4. **Special S-Triko Lane** - a lane selected and marked by the BTMD and the City Engineering Office along (1) Molino-Paliparan Road from SM Molino up to the boundary of Bacoor City and Dasmarinas City and (2) along Tirona Highway from Barangay Mabolo 1 up to SM Bacoor for the use of qualified PUTs under the City Ordinance No. 244-2022.

RULE IV IMPLEMENTING PROVISIONS

Section 7. CALIBRATED DEPLOYMENT OF TRICYCLES. The calibrated deployment of public utility tricycle units duly identified and tagged by the Bacoor Traffic Management Department (BTMD) shall be allowed along (1) Molino-Paliparan Road from SM Molino up to the boundary of Bacoor City and Dasmarinas City and (2) along Tirona Highway from Barangay Mabolo 1 up to SM Bacoor subject to strict compliance by the tricycle operators and drivers concerned with the following conditions:

1. Only PUTs duly outfitted with a global positioning device and with a "Special S-Trike Lane Sticker" by the BTMD shall be allowed to use the said routes;
2. The said PUTs shall only be allowed to use the said route between 11:00 a.m. and 3:00 p.m. on any given day, and
3. The said PUTs shall not stray away from the Special S-Trike Lane to be identified and created by the BTMD, subject to the availability of funds.

Section 8. APPLICATION FOR A SPECIAL S-TRIKE LANE STICKER. The following shall be the procedures for the application of a Special S-Trike Lane Sticker:

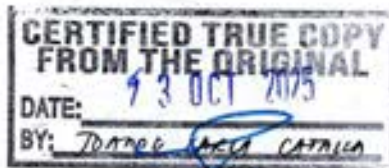
1. The PUT operator must submit a letter of intent to be deployed in S-Trike Lane either along Molino-Paliparan Road or along Tirona Highway. The letter must attach a copy of the OR/CR of the tricycle units and their franchise certificates.
2. The BTMD shall inspect the tricycle units to determine whether they are in good running condition and whether they are ready to be equipped with a global positioning device.
3. After the tricycle units are validated, the BTMD shall issue an endorsement letter identifying the qualified tricycle units and indicating that they are qualified for deployment.
4. The PUT operator shall proceed to pay the calibrated deployment fee to the City Treasurer's Office.
5. The PUT operator shall present the official receipt to BTMD, which will tag the tricycle units with a Special S-trike Lane Sticker.

Section 9. INSTALLATION OF GPS. The BTMD shall coordinate with the public tricycle operators to inform them about the installation of GPS devices on the PUT as a requirement, along with the grant of a Special S-Trike Lane Sticker. Information to the PUT operators and drivers shall be made for GPS monitoring and how the data will be collected and used, emphasizing privacy laws.

With the assistance of a qualified technician or service provider, BTMD shall provide and install GPS devices on the public tricycles already tagged with a Special S-Trike Lane Sticker. It shall be ensured that the installation is done securely and does not interfere with the normal operation of the motor vehicles. Testing and calibration of the GPS devices must be made to ensure they are properly and accurately functioning. Training for public tricycle operators on the proper use of GPS devices may also be provided, ensuring they understand the benefits and purposes of the technology.

Once a GPS device is installed, a notice must be pasted on the windshield of the PUT for information on the passengers. PUTs with dysfunctional GPS devices shall not be allowed to operate on the Special S-trike Lane. The PUT Operator shall inform the BTMD, through the TODA, of its defective GPS device and shall have the device repaired or replaced within a reasonable period.





The BTMD shall conduct periodic maintenance checks on the GPS devices and compliance checks to ensure that operators adhere to the Calibrated Tricycle Deployment Ordinance regulations.

Section 10. MONITORING OF GPS. In coordination with and assistance of the MIS/E-Governance Department and the Bacoor City Disaster Risk Reduction and Management Office, the BTMD shall develop and establish a real-time monitoring system that allows for the tracking and managing of public utility tricycles equipped with GPS devices. Such GPS data collected may be integrated with the existing traffic management and information system to provide accurate and up-to-date information for the BTMD.

The BTMD shall designate personnel who will be given access rights to the GPS portal. Review access to the GPS portal shall be made only upon approval of the BTMD's head upon recommendation of its designated personnel. Data privacy policies must be ensured at all times.

Any violations of the PUT collected through the GPS shall be immediately reported to the BTMD for appropriate action.

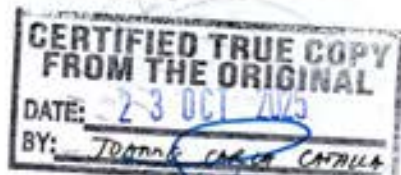
Section 11. CALIBRATED DEPLOYMENT FEE. In order to qualify under the Calibrated Tricycle Deployment Ordinance, the operator of a public utility tricycle must pay a calibrated deployment fee of P1,500.00 every year with the City Treasurer's Office aside from the other fees that should be paid by PUTs to the city government under the Revised Bacoor Traffic Code and other city ordinances.

Proceeds from the collection of a calibrated deployment fee shall be used to implement City Ordinance No. 295-2023 and this IRR, including the purchase of Special S-Trike Lane stickers and installation of road signage and markings, among other things.

Section 12. POWER OF THE BTMD TO CALIBRATE THE NUMBER OF PUBLIC UTILITY TRICYCLES ALONG MOLINO-PALIPARAN ROAD AND TIRONA HIGHWAY. The BTMD is hereby empowered to calibrate the number of PUTs that will be allowed to operate along Molino-Paliparan Road and Tirona Highway. The BTMD is likewise empowered to determine how the said PUTs shall operate on the said roads to prevent traffic congestion.

Upon coordination with the concerned associations of tricycle operators and drivers (TODA), the BTMD shall identify the number of allowable PUTs that may use the Special S-Trike Lane on a given day and time. The number may vary during holidays or special occasions in anticipation of considerable movement among the riding public.





Section 13. INSTALLATION OF ROAD SIGNS AND MARKINGS. The BTMD shall submit to the City Engineering Office (CEO) the proposed Special S-Trike lanes along Molino-Paliparan Road and Tirona Highway, duly approved by the City Mayor, for installation of proper markings on roads.

The BTMD shall ensure the placement of appropriate road signage necessary for implementing the calibrated tricycle deployment on the identified roads. It shall closely coordinate with the CEO to maintain the road signs and markings on the Special S-trike Lanes.

Section 14. REGULAR MONITORING AND REPORTING. The BTMD shall monitor the implementation of the calibrated tricycle deployment along Molino-Paliparan Road and Tirona Highway and shall submit a quarterly report to the City Mayor on the status and impact of implementation, along with any recommendation to improve the administration of the tricycle deployment.

RULE V PROHIBITED ACTS AND PENALTIES

Section 15. PROHIBITED ACTS. The following acts are hereby prohibited:

1. Operating outside of the route approved in the PUT's franchise;
2. Straying away from the Special S-Trike Lane;
3. Operating on the Special S-Trike Lane without the authority of the BTMD and without the GPS device and sticker attached/placed by the BTMD on the PUT unit;
4. Using the Special S-Trike Lane beyond the operating hours mentioned above;
5. Overcharging passengers and
6. Violating traffic laws and ordinances while using the Special S-Trike Lane.

Section 16. PENALTIES. Upon conviction, the following penalties shall be imposed against any person who violates the Calibrated Tricycle Deployment Ordinance or its implementing rules and regulations:

**RULE VI
MISCELLANEOUS PROVISIONS**

Section 17. CHANGES IN MODIFICATIONS TO THE IMPLEMENTING RULES AND REGULATIONS. To appropriately manage the orderly administration of the implementation of the City Ordinance No. 244-2022, the Office of the City Mayor, after consultation with the Bacoor Traffic Management Department, may recommend to the Sangguniang Panlungsod amendments to the said ordinance and, consequently, this IRR.

Section 18. SEPARABILITY. In case any provision of these Implementing Rules and Regulations is declared void by a court of law, the remaining provision of this IRR not affected by the said judicial declaration shall remain valid and enforceable.

SECTION 19. REPEAL. All implementing rules and regulations previously issued and inconsistent with the provisions of the Calibrated Tricycle Deployment Ordinance are hereby modified or repealed accordingly.

Section 20. EFFECTIVITY. These Implementing Rules and Regulations shall take effect immediately upon its approval.
