EXECUTIVE ORDER

EXECUTIVE ORDER NO. MSBR-006-2025 Series of 2025

"AN ORDER STRICTLY ENFORCING CITY ORDINANCE NO. 334-2024, SERIES OF 2024, AND ITS IMPLEMENTING RULES AND REGULATIONS, PROHIBITING BUSINESS ESTABLISHMENTS IN THE CITY OF BACOOR FROM CATERING TO MINORS DURING CURFEW HOURS"

WHEREAS, Section 91 of City Ordinance No. 171-2021, or the "Child Protection and Development Code of the City of Baccor," provides that the period from 10:00 PM to 4:00 AM is declared as "curfew hours" for minors all over the City of Baccor;

WHEREAS, City Ordinance No. 334-2024, Series of 2024, was enacted to prohibit all business establishments in the City of Bacoor from catering to minors during curfew hours, in order to protect the welfare and safety of the minors;

WHEREAS, Executive Order No. 07-2025 Series of 2025 adopts the Implementing Rules and Regulations (IRR) of City Ordinance No. 334-2024, Series of 2024;

WHEREAS, despite the passage of the aforementioned ordinance and IRR, reports have surfaced indicating continued violations by certain establishments, particularly internet cafes and 24-hour convenience stores;

WHEREAS, there is a need to intensify the enforcement measures and ensure full compliance with the ordinance to uphold public order and the protection of children;

NOW, THEREFORE, I, STRIKE B. REVILLA, City Mayor of Bacoor, Cavite, by virtue of powers vested in me by pertinent laws, do hereby ORDER:

Section 1. Strict Enforcement. All departments, units, and offices of the City Government of Bacoor, particularly the City Administrators Office, Business Permit and Licensing Department, Office of Social Welfare and Development, with the assistance of the Sangguniang Kabataan, City Council for the Protection of Children (CCPC), Barangay Council for the Protection of Children (BCPC) and the Philippine National Police – Bacoor City, are hereby directed to strictly enforce City Ordinance No. 334-2024, Series of 2024 and its IRR.

Section 2. Inspection and Monitoring. A composite team composed of the representatives from the aforementioned departments, units, and offices, including the concerned barangays, shall conduct regular and surprise inspections of business establishments during curfew hours.

Section 3. Penalties and Sanctions. Establishments found violating the Ordinance and its IRR shall be subject to the penalties provided therein, as follows:

- A. A fine of two thousand five hundred pesos (PHP 2,500.00) for every minor found to have been catered to, served, or accommodated by the business establishments including, but not limited to, convenience stores, motels, computer shops, internet cafes, coffee shops, and restaurants between 10:00 PM to 4:00 AM shall be imposed against the owner/s and/or manager/s of the aforementioned commercial enterprises.
- B. A fine of two thousand five hundred pesos (PHP 2,500.00) for every minor found violating the curfew hours shall be imposed on the parent/s and/or guardian/s of the apprehended minors.

Section 4. Information Campaign. The City Information and Community Relations Department (CICRD) shall launch an intensive information campaign to inform business owners and the general public of the provisions and penalties under City Ordinance No. 334-2024, Series of 2024, and its IRR.

Section 5. Repealing Clause. All previous issuances inconsistent with the provisions of the Executive Order shall be deemed revoked and amended accordingly.

Section 6. Separability Clause. In the event that any provision found herein shall be found judicially illegal or administratively infirm, any unaffected provisions shall remain in full force and effect.

Section 7. Effectivity Clause. This Executive Order shall take effect immediately upon signing, and it shall remain in full force and effect until repealed, revoked, or amended accordingly.
