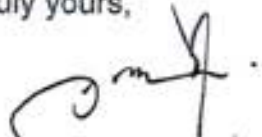

EXECUTIVE ORDER No. 38A-2025

**AN ORDER ADOPTING THE IMPLEMENTING RULES AND REGULATIONS OF
CITY ORDINANCE NO. 47-2019, OTHERWISE KNOWN AS THE "ROAD
CLEARING ORDINANCE OF THE CITY OF BACOR" AS AMENDED BY CITY
ORDINANCE 407-2024**

WHEREAS, Section 16 of R.A. No. 7160 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare including the promotion of safety of its constituents and provision of adequate transportation facilities;

WHEREAS, the Sangguniang Panlungsod enacted and passed City Ordinance No. 47-2019, Otherwise known as the "Road Clearing Ordinance of the City of Bacoor";

WHEREAS, the said ordinance was amended by City Ordinance No. 407-2024, entitled "An Ordinance Amending City Ordinance No. 47-2019," to strengthen the policy in regulating the road clearing operations within the City of Bacoor, including the parking ban on all primary and secondary roads within the City;

WHEREAS, the City Government of Bacoor recognizes the need to issue an Implementing Rules and Regulations pertinent to the above-mentioned Ordinance;

WHEREAS, the Office of the City Mayor of Bacoor, in coordination with the concerned city government offices, issued the above-mentioned Implementing Rules and Regulations that shall govern City Ordinance No. 47-2019 as amended by City Ordinance 407-2024;

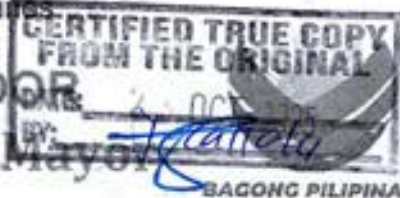
NOW, THEREFORE, I, MICHAEL E. SOLIS, Acting City Mayor of Bacoor, Cavite, by virtue of the powers vested in me by law, do hereby order for the adoption and implementation of the Implementing Rules and Regulations of City Ordinance No. 47-2019, as amended by City Ordinance No. 407-2024, herein attached.

Section 1. Implementing Rules and Regulations (IRR). Attached herein are the Implementing Rules and Regulations of City Ordinance No. 407-2024, which shall form part of this Executive Order. This shall be known as the "Implementing Rules and Regulations of City Ordinance NO. 47-2019, Otherwise Known as the Road Clearing Ordinance, as amended by City Ordinance No. 407-2024. All affected offices and departments are hereby ordered to adopt the said implementing rules and regulations and be guided accordingly. Strict compliance and observance of all city government officials and employees to this Implementing Rules and Regulations is hereby ordered.

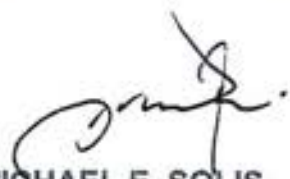
Section 2. Repealing Clause. All previously issued orders and directives inconsistent with any provision found herein shall be deemed repealed, revoked, or amended accordingly.

Section 3. Separability Clause. In the event that any provision found herein shall be judicially or administratively declared illegal or infirm, the remaining provisions shall remain in full force and effect.

Section 4. Effectivity Clause. This Executive Order shall take effect immediately upon its signing and remain in full force and effect until repealed, revoked, or amended accordingly.

SECTION 5. Implementing Agencies. The Office of the City Mayor, in conjunction with the Bacoor Traffic Management Department (BTMD), City Inspection and Compliance Unit (CICU), and the Liga ng mga Barangay, shall be the lead implementing agencies for the implementation of this IRR. Other city government departments, units, or offices, as may be directed by the City Mayor, shall assist in the effective implementation of this IRR.

RULE II
DECLARATION OF POLICY AND DEFINITION OF TERMS

SECTION 6. Declaration of Policy. It is the policy of the City Government of Bacoor to:

1. Effectively implement DILG Memorandum Circular No. 2019-121, which mandates local government units to reclaim public roads, sidewalks, alleys, and other public thoroughfares and clear them of illegal structures, along with other subsequent DILG directives instructing the LGUs to conduct road clearing under the Bagong Pilipinas Program;
2. Improve the flow of pedestrian and vehicular traffic in various public thoroughfares within the City of Bacoor by reducing road obstruction on the roads, including illegal parking on most city roads;
3. Balance vehicular volume vis-à-vis the available road capacity to provide acceptable conditions to travelers within the City of Bacoor;
4. Create a system of accountability for the effective implementation of the Ordinance and this IRR.

SECTION 7. Definitions. As used in these Rules, the following terms are hereby defined as follows:

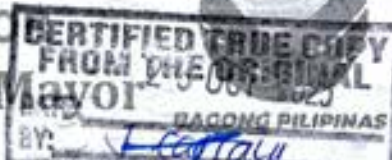
1. **Public Road** – Any street, highway, avenue, alley, or pathway designated for public use and under the jurisdiction of the local government or national agencies.
2. **Sidewalk** – A portion of the road designated for pedestrian use, typically adjacent to the carriageway, and intended to provide a safe passage for people.
3. **National Primary Roads** – A contiguous length of significant road section extending linearly without any breaks or forks that connect major cities with at least around 100,000 population, comprising the main trunk line or the backbone of the national road system
4. **National Secondary Roads** – directly connects cities, major ports, airports, ferry terminals, tourist service centers, and national government infrastructure to national primary roads; connects provincial capitals within the same region.
5. **Provincial Roads** – connect national roads to cities, municipalities, and barangays through rural areas.

6. **Municipal and city roads** – roads within a poblacion, connect to provincial and national roads, and provide inter-barangay connections to major municipal and city infrastructure
7. **Solidarity Route** - private roads located within the private subdivisions where privately-owned vehicles registered under the name of Bacoor City residents and motor vehicles owned, operated, or registered under the name of either the city government or of any of its officials are allowed to use, subject to certain limitations.
8. **Obstruction** – Any structure, object, or activity that impedes the free and safe passage of pedestrians, vehicles, and emergency services along public roads, sidewalks, and alleys, including but not limited to illegal structures, parked vehicles, vendors, or business stalls, debris, and unauthorized utility installations. It may be a temporary or permanent obstruction.
9. **Encroachment** – The unauthorized occupation or use of any portion of a public road, sidewalk, or right-of-way by private individuals, businesses, or entities.
10. **Public Safety Hazard** – Any obstruction or condition along public roads or sidewalks that poses a risk to public safety, including but not limited to blocked fire exits, unstable structures, or restricted access for emergency responders.
11. **Clearing Operations** – The systematic removal of obstructions, illegal structures, or any unauthorized use of public roads and sidewalks in compliance with national and local regulations.
12. **Enforcement Units** – The designated team or personnel authorized to implement the provisions of the ordinance and this IRR, which conduct inspections, issue notices, and oversee clearing operations. This unit is composed of the personnel from the Bacoor Traffic Management Department, City Inspection and Compliance Unit, and barangay officials.

RULE III
IMPLEMENTING PROVISIONS

SECTION 8. Ban on Parking on All Primary and Secondary Roads, including Solidarity Routes. The parking of all types of motor vehicles on the following roads is hereby prohibited:

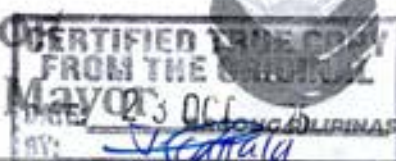

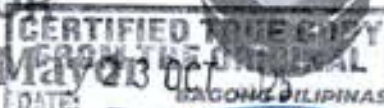

SECTION 8. Automatic Inclusion in the Prohibition. All other roads that may be subsequently declared as national roads, provincial roads, city roads, or solidarity routes after the effectivity of the Ordinance and this IRR shall automatically be covered by the prohibition on parking under the Ordinance and this Rule.

SECTION 9. Public Information and Signages. The BTMD is hereby directed to install appropriate no-parking signs on all roads covered under the Ordinance and this IRR. Signage must be clear and visible to all drivers. The City Information and Community Relations Department shall assist in the public information of the Ordinance and this IRR. All Barangays in the City of Bacoor shall aid in installing the no-parking signs and disseminating public information in their respective jurisdictions.

SECTION 10. Cancellation of Permits. All permits, whether express or implied, issued in favor of private natural or juridical persons for the use of public roads, sidewalks, and other public thoroughfares within the City of Bacoor are hereby canceled.

SECTION 11. Authority to Remove Obstructions. The Bacoor Traffic Management Department (BTMD), the City Inspection and Compliance Unit (CICU), the Task Force on Abatement, Clearing and Preservation of Public Spaces (TF-ACPOPS), and all barangay officials in the City of Bacoor are hereby authorized empowered to remove all illegally constructed structures, encroachments, or obstructions on public thoroughfares within the City. If an obstruction or illegal structure is deemed a public safety hazard, posing imminent danger to life, health, or property, the BTMD, CICU, and barangay officials, in coordination with concerned government agencies, shall facilitate the removal or rectification of the hazard.

SECTION 12. Coordination with Other City Departments/Units or Agencies. In instances requiring technical expertise or specialized intervention, such as electrical hazards, structural safety concerns or other technical matters, the Office of the Building Official (OBO), City Engineering Office (CEO), City Environment Services Department (CESD), Office of the City Health Services (OCHS), Bureau of Fire Protection (BFP), and City Disaster Risk Reduction and Management Office (CDRRMO), and other relevant government agencies shall be consulted prior to the execution of the removal.

SECTION 13. Clearing Procedures and Legal Compliance. The procedure for clearing road obstructions or abatement of nuisance and hazardous structures shall be based on the procedures outlined in Executive Order No. 56-2022¹.

These procedures must ensure compliance with the existing national law (Civil Code, National Building Code, Fire Code, Land Transportation and Traffic Code, Local Government Code, etc.), their respective implementing rules and regulations, including the relevant issuances of the DPWH, DENR, BFP, and DILG.

SECTION 14. Budget. The funds necessary for the continued implementation of the ordinance and this IRR shall be sourced from the appropriated budget of the Office of the City Mayor or from such amounts as may be subsequently allocated by the Sangguniang Panlungsod. The utilization of these funds shall be subject to compliance with all applicable laws, rules, and regulations governing the procurement and disbursement of public funds and supplies.

SECTION 15. Monitoring and Evaluation. The BTMD and CICU shall conduct regular monitoring of the primary and secondary roads in the City to ensure compliance and effectiveness, submitting a monthly report to the Office of the City Mayor.

The report shall include the areas inspected, type of obstructions observed, the hazard or danger posed to the public, photo or video documentation for additional reference, and recommendations for mitigation or removal.

Depending on the nature of the obstruction or hazard, the BTMD or CICU shall notify the concerned agency/ies (OBO, CEO, CESD, OCHS, CDRMO, BFP, etc.) to assist in risk assessment and facilitate proper removal or abatement.

Residents may likewise report to their barangay authorities or the BTMD any observed obstructions or hazards on designated primary and secondary roads. Such a report may be submitted through the barangay's official contact details, including its social

media account, specifying the exact location of the road obstruction, the nature of the hazard, and photo or video documentation, if available.

Upon receiving a concerned citizen's report, the barangay shall immediately inspect the reported area, document the findings, and forward the report to the BTMD or CICU for coordination concerned city department and appropriate action.

The BTMD shall consolidate all reports and prepare an annual evaluation report for operational improvements and/or policy adjustments.

RULE IV
FINAL PROVISIONS

SECTION 16. Changes or Modifications of the Implementing Rules and Regulations. To appropriately administer the efficient and effective implementation of the Road Clearing Ordinance, as amended by City Ordinance No. 407-2024, the Office of the City Mayor, after consultation with the Office of the Building Official and other concerned city offices, may recommend to the Sangguniang Panlungsod amendments to said Ordinance, and consequently, this IRR.

SECTION 17. Repeal. All local rules or regulations that are inconsistent with or contrary to the provisions of this IRR are hereby repealed and modified accordingly.

SECTION 18. Separability. If any section or provision of these Implementing Rules and Regulations is declared invalid or unconstitutional by a court of competent authority, the remaining provisions not affected thereby shall remain valid and continue to be in full force and effect.

SECTION 19. Effectivity. These Implementing Rules and Regulations shall take effect upon their approval.
