ORDINANCE NO. 10 S-1997

AN ORDINANCE GRANTING ALLPOINT LEISURE CORPORATION AUTHORITY TO OPERATE BINGO HALLS IN SM BACOOR, CAVITE.

WHEREAS, Allpoint Leisure Corporation a corporation duly organized and existing under and by virtue of Philippine laws, with principal office at No. 302 One magnificent Mile, San Miguel Ave., Ortigas Center, Pasig City, has applied for a permit to establish and operate a Bingo Hall in SM, Bacoor, Cavite;

WHEREAS, Allpoint Leisure Corporation seeks to operate bingo halls in Bacoor, Cavite and request the Sangguniang Bayan to grant it the necessary franchise and permit to do the same;

WHEREAS, under Republic Act No. 7160, the Sangguniang Bayan has the authority to grant franchises, enact ordinances authorizing the issuance of permits or licenses and enact ordinances levying taxes, fees and other charges;

NOW, THEREFORE, BE ORDAINED by the Sangguniang Bayan of Bacoor, Cavite, in session assembled, that:

SECTION 1. There is hereby granted to Allpoint Leisure Corporation or its assignee the authority to operate bingo halls in Bacoor, particularly at the SM Bacoor, and conduct therein bingo games;

SECTION 2. Allpoint Leisure Corporation shall secure a Mayor's permit for the operation of bingo halls;

SECTION 3. *The authority to operate bingo halls granted herein shall be limited as follows:*


- a. The operation of bingo halls shall be only within the above identified commercial areas;*
- b. The operation of bingo halls do not include the playing of game slot related to or other than bingo; and*
- c. Minors and students in uniform are prohibited to watch or participate in the bingo games.*


SECTION 5. *The grant of authority to operate bingo games herein shall be for a period of five (5) years; renewable for another 5 years, at the option of the grantee.*

SECTION 6. *In lieu of all taxes, a franchise fee of not more than one-half (1/2) of one (1) percent of the gross revenue of Allpoint Leisure Corporation shall be imposed and be made payable yearly.*

SECTION 7. *This ordinance shall take effect immediately upon its approval.*
