ORDINANCE NO 4 S-97

AN ORDINANCE PROHIBITING THE PARKING OF ANY KIND OR TYPE OF MOTOR VEHICLE ALONG THE DESIGNATED PORTION OF MAIN THOROUGHFARES OF THIS MUNICIPALITY FROM 5:00 IN THE MORNING TO 12 MIDNIGHT EXCEPT FOR PURPOSES OF LOADING AND UNLOADING AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, the traffic situation in Bacoor, Cavite has gone from bad to worse;

WHEREAS, the rampant illegal and indiscriminate parking of motor vehicles, especially the ten-wheeler type truck, along public road, street, sidewalks and thoroughfares or portion thereof in this municipality has greatly contributed to traffic congestion and hazards to pedestrians;

WHEREAS, it has become imperative to reduce to a great extent traffic accidents and congestions in the municipality to promote the welfare of its inhabitants by prohibiting the drivers and owners of said trucks and such other motor vehicles from illegally parking them in any public road, street or thoroughfare in Bacoor, Cavite;

WHEREAS, the Clean and Green Program of the National Government cannot be implemented properly and trees already planted along the roads tend to die because of the drivers indiscriminate mode of parking and the smoke that belches from their vehicles exhaust pipes (tambucho);

NOW THEREFORE:

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite in a regular session assembled that:

Section 1 - Parking of any kind or type of motor vehicle shall be prohibited from 5:00 AM to 12 PM except for loading and unloading purposes, along the designated portion of main thoroughfares, to wit:

- a) along Aguinaldo Highway up to Coastal Road
- b) the whole Evangelista Street
- c) the whole Tirona Highway
- d) along Aniban Road up to Paliparan
- e) along Bayanan up to Mambo

Section 1-A - Exception: Parking of four (4) wheeled vehicle is temporarily allowed on specific places where there are wakes, school and religious activities, wedding and birthday celebration, the permit of which must be first secured from the Barangay Captain concerned;

Section 2 - The term "cargo trucks" as used in this Ordinance shall be understood to mean motor vehicles, principally intended for carrying cargo and having license plates of the following classification: "S", "T", "TH", "TRLB", "HLB", and "TRJ", to include other vehicles such as lorries, vans, tankers or other delivery vehicles, whether loaded or empty, having a gross capacity weight of more than four thousand (4,000) kilos.

Section 3 - Penalty for Violators:

3.1 - Summons or citation tickets with penalty shall be issued on illegally parked vehicles to be redeemed at the Municipal Motorpool within twenty four (24) hours, upon payment of the appropriate penalty prescribed.

3.2a- Penalty for jeep, passenger jeepney, cars and other four (4) wheelers - Three Hundred Pesos (P300.00) and impounding of vehicles with One Hundred Pesos (P100.00) per day for storage fee.

3.2b- Penalty for six (6) wheelers - Six Hundred Pesos (P600.00) and impounding of vehicles with Two Hundred Pesos (P200.00) per day for storage fee.

3.2c- Penalty for ten (10) wheelers - One Thousand Pesos (P1,000.00) and impounding of vehicles with Three Hundred Pesos (P300.00) per day for storage fee.

Section 4-1 - It is hereby ordered to tow stalled vehicles at the expense of the owner and that said owner pay the required penalty for violation thereof.

4-2 - Towing Charges or Fees

- For cars and four (4) wheelers - P 800.00
- For six (6) wheelers - P1,500.00
- For ten (10) wheelers - P2,000.00

Section 5 - Such fees and charges shall accrue exclusively to the local government unit of Bacoor as mandated by Section 129 under the title Local Taxation and Fiscal Matters;

Section 6 - That the amount of One Hundred Thousand Pesos (P100,000.00) be appropriated from whatever funds available for the expense on signages and notices arising from the implementation thereof.


Section 7 - Any ordinances or any part thereof which is inconsistent herewith is hereby repealed or modified accordingly.

Section 8 - This Ordinance shall take effect upon its approval and after the required publication or notice.




