ORDINANCE NO. 5 S-97

AN ORDINANCE REQUIRING ALL INDUSTRIAL, COMMERCIAL, EDUCATIONAL ESTABLISHMENT AND RESIDENTIAL OWNER TO CLEAN THEIR AREAS OF RESPONSIBILITIES AND TO PUT ADEQUATE AND SUFFICIENT TRASH RECEPTACLES WITHIN THE VICINITY OF THEIR ESTABLISHMENT AND PROVIDING PENALTY FOR VIOLATION THEREOF.

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite, in regular session assembled that:

SECTION 1. - The purpose of this ordinance as public interest so require is the primary duty of every citizen to have his share of responsibility in the keeping of his community and as stated in Section 2 under the Declaration of Policy in Ecology and Environment "that the maintenance and preservation of a sound ecological balance and clean environment are salient concern embodied in the Local Government Code".

SECTION 2. - All industrial, commercial, educational establishment and residential owner are required to clean their areas of responsibilities and to put adequate and sufficient trash receptacles within the vicinity of their establishment.

SECTION 3. - Violation of this Ordinance shall subject the offender upon conviction to a fine of not less than One Thousand Pesos (P1,000.00) but not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six (6) months or both fine and imprisonment at the discretion of the court. In case of establishment any license granted to the person or entity so violating the same may be revoked.
