ORDINANCE NO. 8 S-97

AN ORDINANCE AMENDING SECTION 6B.04, CHAPTER IV, ARTICLE B OTHERWISE KNOWN AS "CODE OF GENERAL ORDINANCES" OF BACOR, CAVITE

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite, in regular session assembled that:

SECTION 1. SECTION 6b.04 is hereby amended to read as follows: "Any person who violates any provision of this article shall be punished by a fine of not more than Two Thousand Five Hundred (P2,500.00) Pesos or imprisonment of not more than six (6) months or both fine and imprisonment at the discretion of the Court, without prejudiced to the imposition of a higher penalty under the provision of PD 825 and other laws. If a violator is a corporation, firm or other corporate entities, the penalty shall be imposed upon the president, manager, director or person responsible for its operation. The vehicle which had been used to dump garbage, filth and other waste matters will be confiscated and be release only upon payment of Two Thousand Five Hundred (P2,500.00) Pesos within a period of ten (10) days;"

SECTION 2. This ordinance shall take effect upon its approval.
