ORDINANCE NO. 14 S-98

AN ORDINANCE IMPOSING AMUSEMENT TAXES FROM PROPRIETORS, LESSEES, OPERATORS OF BINGO SOCIALS/GAMES AND VIDEO ARCADES.

WHEREAS, each Local Government Unit is empowered under the provision of R.A. 7160 otherwise known as the Local Government Code to create its own services of revenues;

WHEREAS, the unprecedented growth and development experienced by the Municipality of Bacoor, for the last few years saw the proliferation of Bingo games and Video arcades;

WHEREAS, to cure the pernicious effect of the aforesaid activities it is for the Local Government to regulate the operation of the same and at the same time increasing revenues thereof.

NOW THEREFORE:

SECTION 1. Each proprietors lessees and operators of Bingo games/Socials and Video arcades within the jurisdiction of the municipality shall be levied an amusement tax in the amount ~~equivalent to~~ ^{not exceeding} thirty percent (30%) of the gross receipts.

SECTION 2. Amusement taxes shall be payable directly to the Office of the Municipal Treasurer at Quarterly, Semi-annually or Annually basis.

SECTION 3. EFFECTIVITY. This ordinance shall take effect within fifteen (15) days from its publication in a newspaper of General Circulation in the province of Cavite.


