**AN ORDINANCE REQUIRING BUSINESS ESTABLISHMENTS
TO LIST THE PURCHASERS AND USE OF CANNED SPRAY
PAINTS AND PROVIDING PENALTY THEREOF**

Sponsored by: **Councilor Saturnino F. Enriquez, Jr.**

WHEREAS, the municipality of Bacoor has kept the maintenance of the cleanliness of its surroundings as one of its top priorities;

WHEREAS, the proliferation of unsightly graffiti on the walls and façade of residences and business establishments has been observed to have increased in recent times;

WHEREAS, these graffiti at times contain lewd words that impressionable children can read;

WHEREAS, this vandalism can affect business establishments and cost the owners a sum to repair;

WHEREAS, without controlling these instance can create an unfavorable image on the municipality;

WHEREAS, the monitoring of the purchase of these canned spray paint by listing the purchasers and their intended use of them can discourage buyers from using them for vandalism, and can give the means for authorities to pin down violators;

WHEREAS, the procurement of these paints are best monitored through the establishments that sell them;

THEREFORE, be it ordained by the Sangguniang Bayan of Bacoor, province of Cavite in regular session that:

Section 1. Business establishments within the jurisdiction of the municipality of Bacoor are required to list down the names of the purchasers of canned spray paint and these buyers' intended use them.

Section 2. PENALTY. Any person or juridical person violating the above-mentioned prohibitions shall, upon conviction thereof, be punished by a fine of Two Thousand Five Hundred Pesos (₱ 2,500.00) or an imprisonment of not less than (1) month nor more than six (6) months, or both such fine and imprisonment at the discretion of the court.

Section 3. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 4. EFFECTIVITY. This ordinance shall take effect upon its approval.


