ORDINANCE NO. 4-S-99

AN ORDINANCE IMPOSING HEALTH EXAMINATION FEES

Whereas, the Municipal Health authorities had forwarded a request for a passage of an Ordinance to justify the imposition of the current health examination fees;

Whereas, the funds derived from this fees shall be used by the Local Government of Bacoor, Cavite to improve health services and upgrade its facilities and equipment to cope with the growing demand for health care by its citizenry;

Whereas, to realize this objective, it is of utmost necessity that health examination fees be imposed;

NOW, THEREFORE ;

Be it ordained by the Sangguniang Bayan of Bacoor, Cavite in session assembled, that :

Section 1: The following Health Examination Fees shall be imposed to wit ;

D. Cervical Spine	130.00
E. Lumbo Sacral AP LAT	130.00
F. Paranasal Sinuses	200.00
G. Abdomen	100.00
H. K.U.B.	100.00
I. Pelvic Joint	100.00
J. Hip Joint	100.00




Section 2. This Ordinance shall take effect fifteen (15) days upon its publication.
