ORDINANCE NO. 1-S-2000

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION FOUR HUNDRED TWENTY SIX THOUSAND FIVE HUNDRED PESOS (Ph P 1,426,500.00) OR SO MUCH THEREOF AS MAYBE NECESSARY OUT OF THE FUNDS IN THE MUNICIPAL TREASURY NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE FOR THE PAYMENT OF EXPENSES TO BE INCURRED IN CONNECTION WITH THE POVERTY ALLEVIATION OF THE MUNICIPAL EMPLOYEES OF THE MUNICIPALITY

WHEREAS, the Sangguniang Bayan of Bacoor approved unanimously a Resolution No. 6- S - 2000 dated January 18, 2000, granting Poverty Alleviation Allowance to the Municipal Officials and Employees of this Municipality;

WHEREAS, this august body had approved Resolution No. 43-S-99, dated December 21, 1999, Reverting the accumulated amount of One Million Six Hundred Eighty Thousand Pesos (Ph P 1,680,000.00) out of savings of different offices/departments the Poverty Alleviation Allowance of Municipal Officials and Employees of the Municipal Government and as additional appropriation for job contract to streetsweepers;

Be it enacted by the Sangguniang Bayan of Bacoor, Province of Cavite in a regular session assembled that:

SECTION 1 - The purpose of this Ordinance is to appropriate the amount of One Million Four Hundred Twenty Six Thousand Five Hundred Pesos ( Ph P 1,426,500.00 ) or so much thereof as may be necessary to be made available for the payment of expenses to be incurred in connection with the Poverty Alleviation Allowance of the Municipal Officials and Employees of the Municipality;

SECTION 2 - There is hereby appropriated the sum of One Million Four Hundred Twenty Six Thousand Five Hundred Pesos ( Ph P 1,426,500.00) out of any available funds in the municipal treasury for the payment of expenses to be incurred in connection with the Poverty Alleviation Allowance of the Municipal Officials and Employees of the Municipality;

SECTION 3 - The Municipal Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

SECTION 4 - This ordinance shall take effect upon its approval.

ENACTED by the Sangguniang Bayan of Bacoor, Province of Cavite this 18<sup>th</sup> day of January, 2000.


