Ordinance 2-S-2000

ORDINANCE AMENDING ORDINANCE NO. 13-S-98
REGARDING TRICYCLE REGULATIONS

WHEREAS, pursuant to Art. 447 paragraph 3 (VI) of the Local Government Code, every Local Government Unit is authorized to regulate the operation of Tricycles and for this purpose grant the appropriate franchise for the operation thereof;

WHEREAS, pursuant to the aforesaid provision of the Local Government Code, the Land Transportation Franchising Regulatory Board has delegated the power to regulate tricycle operation to every Local Government Unit;

WHEREAS, it is necessary to regulate tricycle operation in the interest of the riding public and to maintain orderly traffic in the Municipality of Bacoor;

NOW, THEREFORE:

SECTION 1. All applicants for Tricycle Operation Permit (TOP) shall pay to the Municipal Treasurer the following fees:

- a. Local Supervision Fee of Sixty Six Pesos (P 66.00) per unit.
- b. Filing Fee of Two Hundred Fifty Pesos (P 250.00) for regular franchise or Three Hundred Fifty (P 350.00) for franchise holding Special Permits for the first five (5) units, plus Twenty Five Pesos (P 25.00) for every unit in excess thereof.
- c. A side car number fee in the amount of Ninety Pesos (P 90.00) per unit.

SECTION 2. The TOP shall be valid for Two (2) years subject to renewal on the second week of February 2000 and every subsequent 2nd week to the end of the said month thereof. The body number and local supervision fee shall be renewed yearly.

SECTION 3. Procedure.

- a. In order to apply for a franchise and for the renewal of body number, the operator shall secure an endorsement from the local Tricycle Operators and Drivers Association (TODA) and the Federation of Tricycle Operators and Drivers Association of Bacoor (FETODAB), an endorsement from the FETODAB to the Tricycle Regulatory Unit (TRU) and a drug test result of the tricycle's driver from the Local Transportation Office (LTO) or any certified medical establishment to the TRU for assessment.
- b. The assessment from the TRU shall be paid at the Municipal Treasurer's Office.
- c. The Franchise and Body Number sticker shall be released upon the issuance of the receipt of payment from the Treasurer's Office.

SECTION 4. That each tricycle authorized to operate within the limits of the Municipality shall be required to post inside the tricycle the unit schedule of fares payable by passengers. Likewise, the said schedule shall be required to be posted to conspicuous places of every tricycle terminal.

SECTION 5. The terminals of each TODA are established as follows:

SECTION 6. The office of the Mayor together with the Committee shall have the right to change the location of the TODA terminal.

SECTION 7. Color Coding

- a. **Restriction.** The routes of these tricycles shall be limited to their respective jurisdiction as indicated by the colors assigned to them. These colors shall be displayed by attaching their color-coded stickers on the tricycle units.
- b. **Exemptions.** Those holding Special Permits and those using their units for personal functions and emergency cases are exempted from these penalties.

SECTION 8. **Penalties.** Those found to be operating without the proper license (violation of Sections 1, 2, and 3) shall be fined Two Thousand Five Hundred Pesos (P 2,500.00). Those with delayed payments shall be fined Five Hundred Pesos (P 500.00). Those violating Section 4 (unit schedule of fares) shall be fined Five Hundred Pesos (P 500.00).

Anyone found violating the established routes (Section 7) shall be fined Five Hundred Pesos (P 500.00) and be given a warning on the first offense. On the second offense, a fine of One Thousand Five Hundred Pesos (P 1,500.00) and the suspension of TOP shall be imposed. The third offense shall incur a penalty of Two Thousand Five Hundred Pesos (P 2,500.00) and a revocation on the offender's TOP.

SECTION 9. An Arbitration Committee which will be composed of Three (3) Sangguniang Bayan (SB) Members shall be appointed by the SB Members themselves to oversee any discussion or discrepancy in the imposition of the penalty.

SECTION 10. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 11. This ordinance shall take effect Fifteen (15) days after its publication.


