ORDINANCE NO. 08 – S- 2001

**AMENDING ORDINANCE TO ORDINANCE NO.
13-S-98 REGARDING TRICYCLE REGULATIONS.**

WHEREAS, pursuant to Art. 447 paragraph 3 (VI) of the Local Government Code, every local government unit is authorized to regulate the operation of tricycles and for this purpose grant the appropriate franchise for the operation thereof;

WHEREAS, the transportation sector must be able to address the ever increasing needs of the riding public;

WHEREAS, it has been determined that the creation of sub-federations would be necessary to address the clamor of the commuting public;

NOW, THEREFORE;

SECTION 1. Creation of sub-federations in the following areas:

- a. QUEENSROW, which shall be composed of the following local TODA'S:
 1. Queensrow Tricycle Operators and Drivers Associations (QRTODA).
 2. Queensrow West Astroville Parkhomes Garden City Tricycle Operators and Drivers Association (QWAPGTODA).
 3. BonAir Greenvalley Magdiwang Tricycle Operators and Drivers Association (BGMTODA).
- b. MABOLO, which shall be composed of the following local TODAs:
 1. Mabolo Piñahan Tricycle Operators and Drivers Association (MAPTODA).
 2. Mabolo-Dulong Bayan Tricycle Operators and Drivers Association (MADTODA).
- c. SOLDIERS HILL, which shall be composed of the following local TODAs:
 1. Soldiers Hill IV Tricycle Operators and Drivers Association (SHIVTODA).
 2. Green Valley Woodwind Soldiers Hill IV Tricycle Operators and Drivers Association (GVWS4TODA).
- d. BAHAYANG PAG-ASA/MOLINO SHELL, which shall be composed of the following TODAs:
 1. Molino Shell Tricycle Operators and Drivers Association.
 2. Molino 5 Bahayang Pag-asa Home Owners Tricycle Operators and Drivers association.

SECTION 2. Each sub-federation shall have its own set of rules and regulations which shall be determined and formulated by the bonafide members of the local federation and approved by the Chief Executive and the Committee on Public Utilities and Facilities.

Each federation shall have a president, 1st vice president, 2nd vice president, secretary, treasurer, auditor, sgt. at arms which shall be elected among the officers of the local TODA except that of the president of the sub-federation which shall be elected from the local presidents.

SECTION 3. Membership in the Federation of Tricycle Operators and Drivers Association of Bacoor (FETODAB).

Sub-federation shall have a single representative, who shall be its president to the Federation of Tricycle Operators and Drivers Association of Bacoor (FETODAB).

SECTION 4. However, where so public interest deems it necessary, the Chief Executive may, at his discretion, administer changes and implementation that may vary from any of the above mentioned or existing provisions of any ordinance. The implementing rules and regulations of such acts shall be in consonance with the findings of the Chief Executive and the Committee on Public Utilities and Facilities.

SECTION 5. All ordinance or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified.


SECTION 6. This ordinance shall take effect Fifteen (15) days after its publication.
