**AN ORDINANCE REGULATING THE DISTRIBUTION OF PLASTIC BAGS AND POLYSTYRENE (common name STYROFOAM), PROVIDING PENALTIES FOR VIOLATION THEREOF**

Be it ordained by the Sangguniang Bayan of Bacoor, Province of Cavite, that;

**SECITON 1. DEFINITION**

1. **PLASTIC BAG** shall mean plastic carrier bag with or without handles which is designed for the general purpose of carrying goods purchased by consumers.
2. **STYROFOAM** – a lightweight rigid, cellular material formed from a synthetic hydrocarbon polymer.
3. **VENDOR**- any person, natural or juridical, engaged in the selling of food and merchandise.
4. **VENDEE** – any person, natural or juridical, to whom something is sold.

**SECTION 2** - It shall be unlawful for vendors to distribute plastic bags and/or Styrofoam to vendees in order for the latter to carry food and/or merchandise purchased from the former.

**SECTION 3** – All persons or establishments found violating Section 2 hereof shall be held liable for;

| c. Third Offense  | - | revocation of the business permit |

In case the violator is an establishment, the owner, president and/or general manager of the same shall be held liable.


**SECTION 4. – REPEALING CLAUSE**


All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby deemed repealed.

**SECTION 5. – EFFECTIVITY CLAUSE**

This ordinance shall take effect 15 days after publication in a newspaper of general circulation within the Province of Cavite.




