ORDINANCE NO. 4 - S - 2002

AN ORDINANCE PROHIBITING ALL COMMERCIAL/BUSINESS ESTABLISHMENTS ALONG E. AGUINALDO HIGHWAY (ZAPOTE PORTION), EVANGELISTA ROAD, ANIBAN-MOLINO ROAD (ANIBAN-ZAPOTE PORTION) FROM LEASING AND/OR SUB-LEASING PORTION OR PORTIONS OF THEIR ESTABLISHMENT APPROPRIATED FOR THE PARKING OF ITS CUSTOMERS AND CLIENTS.

WHEREAS, the perennial bottlenecks of traffic in the Municipality of Bacoor are the areas of E. AGUINALDO HIGHWAY (ZAPOTE PORTION), EVANGELISTA ROAD, ANIBAN-MOLINO ROAD (ANIBAN-ZAPOTE PORTION);

WHEREAS, the primary cause of traffic gridlock in the Municipality of Bacoor in the abovesaid areas are the vendors occupying portion or portions of parking spaces of commercial establishments therein under the pretext of a lawful lease from the latter or by virtue of its tolerance on the former;

WHEREAS, under Rule XIX, National Building Code of the Philippines, every building, i.e., commercial/business establishment must provide its clients and customers with ample parking space;

WHEREAS, the vendors occupying portion or portions of the parking spaces of commercial/business establishment along E. AGUINALDO HIGHWAY (ZAPOTE PORTION), EVANGELISTA ROAD, ANIBAN-MOLINO ROAD (ANIBAN-ZAPOTE PORTION) are the primary contributors of garbage therein;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACOR, PROVINCE OF CAVITE, IN SPECIAL SESSION ASSEMBLED, THAT:

**SECTION 1.** All commercial/business establishments doing business in the areas of E. AGUINALDO HIGHWAY (ZAPOTE PORTION), EVANGELISTA ROAD, ANIBAN-MOLINO ROAD (ANIBAN-ZAPOTE PORTION) are hereby prohibited to lease portion or portions of their areas dedicated as parking space for their customers and clients.

**SECTION 2.** Any commercial/business establishments found violating this ordinance shall be penalized with the revocation of their duly issued Business Permits from the Office of the Mayor of the Municipality of Bacoor.

**SECTION 3.** All municipal ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 4.** This ordinance shall take effect 15 days after posting in public places and ratification of government authorities concern.






