ORDINANCE NO. 8 S-2002

AN ORDINANCE AMENDING THE LOADING AND UNLOADING ZONES FOR ANY KIND OR TYPE OF MOTOR VEHICLES FOR HIRE IN THE MUNICIPALITY OF BACCOOR.

WHEREAS, the increase of population comes with it the increase in vehicular traffic specifically, public utility vehicles attending the ever growing needs of the populace;

WHEREAS, the uncontrolled and unabated loading and unloading of passengers or goods of the said public utility vehicles contribute to the congestion of vehicular traffic;

WHEREAS, in order to bring order in the road/streets it is necessary that specific loading and unloading station or stations be designated where the public utility vehicles may load and unload its passengers or goods;

WHEREAS, for this purpose the seventy three (73) barangays comprising the municipality of Bacoor, have enacted its respective ordinances to designate loading and unloading areas.

WHEREAS, for uniformity and consistency it is necessary that all the ordinances enacted by the different barangays of the Municipality be standardized into one ordinance.

NOW THEREFORE for and in consideration of the foregoing be ordained by the Sangguniang Bayan in a special session assembled that :

SECTION 1. - That immediately upon the effectivity of this ordinance all public utility vehicles are allowed to load or unload passengers or goods only at the designated loading and unloading area(s) in all the major roads and thoroughfares of the Municipality such as but not limited to the following, to wit :

1. Gen. Evangelista Road
2. Gen. Tirona Road
3. Gen. E. Aguinaldo Highway
4. Aniban - Molino Road
5. Bayanan - Mambog Road
6. Real - Salinas Road
7. Marcos Alvarez Road (Bacoor side)

SECTION 2. - That the Office of the Mayor is designated to specify within five (5) days from the effectivity of this Ordinance within which to identify the specific loading and unloading area (s) in the entire municipality especially along its major roads and thoroughfares especially in the above-named main roads and streets, taking into account the very objectives for the enactment of this Ordinance and convenience of the people;

SECTION 3. - Any person who violates the provisions of Section 1 hereof shall be subject to the penalties provided for under existing laws being enforced by the Land Transportation Office.

SECTION 4. - Immediately after the effectivity of this Ordinance the Office of the Mayor shall issue implementing guidelines for the effective implementation of the provisions embodied herein.

SECTION 5. - All ordinances or parts thereof inconsistent with the provisions hereof is deemed amended modified or repealed.
