ORDINANCE No. 6 - S - 2004

AN ORDINANCE ESTABLISHING PARKING RULES AND REGULATIONS INSIDE THE ZAPOTE PUBLIC MARKET AND IMPOSING FEES FOR THE USE OF PARKING SPACES THEREAT.

WTIEREAS, the absence of strict parking regulations in Zapote Public Market and fees for the use of parking areas thereat caused traffic congestion therein to the discomfort and inconvenience of the buying public;

WTIEREAS, there is a need to maximize the utilization of available parking slots inside the Zapote Public Market through the imposition of parking regulations and imposition of parking fees so as to minimize vehicular congestion therein;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACOOR, PROVINCE OF CAVITE, IN A SESSION ASSEMBLED, THAT:

SECTION 1. For the orderly operations of Zapote Public Market, the following rules and regulations are hereby ordained so as to maintain smooth flow of traffic thereat, to wit:

Section 1.a. Parking is strictly on a "First Come First Serve" basis;

Section 1.b. "Free Parking" is allowed only for the first two hours in all parking slots;

Section 1.c. A twenty pesos (P 20.00) parking fee is to be charged for an additional hour or a fraction beyond the 2-hour free parking;

Section 1.d. Subsequent hours or a fraction thereof is to be charged a parking fee of ten pesos (P 10.00) an hour after the initial assessable parking fee;

Section 1.e. All vehicles entering and using the designated parking slots must be issued a Parking Slip with the corresponding time of entry;

Section 1.f. All parking fees collected upon exit of the market must be covered by a receipt issued by the Office of the Municipal Treasurer and the corresponding Parking Slip indicating the total hours of stay inside the market;

Section 1.g. All delivery vehicles which have been allotted specific unloading docks inside the market. Those that cannot be accommodated in those docks can use the parking slots for unloading of goods provided the appropriate parking fee are paid.

SECTION 2. The Zapote Public Market Administration shall appoint specific market personnel to oversee the parking operations inside the Zapote Public Market who must see to it the smooth flow of traffic therein:

SECTION 3. The Zapote Public Market Administrator shall make a regular report of the operations of the said parking area to the Office of the Mayor;

SECTION 4. All municipal ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly;

SECTION 5. This ordinance shall take effect 15 days after complying with all the formalities under the law.
