**AN ORDINANCE IMPOSING A TRUCK BAN ALONG  
 EVANGELISTA ROAD, BACOR, CAVITE FROM 5:00  
 A.M TO 9:00 A.M AND 3:00 P.M TO 9:00 P.M.**

**WHEREAS**, Section 16 of R.A. 7160 (otherwise known as the Local Government Code of 1991) empowers the municipal government to pass measures to protect the general welfare;

**WHEREAS**, trucks traversing the length of Evangelista Road in Bacoor, Cavite contributes greatly to the traffic problem in that area;

**WHEREAS**, there is an urgent need to limit the access of trucks to Evangelista Road during rush hour to avoid traffic jams;

**NOW, THEREFORE:**

**BE IT ORDAINED** by the Sangguniang Bayan in session assembled that:

**Section 1. Statement of Policy.**—It shall be the policy of the municipal government of Bacoor, Cavite to develop a traffic management scheme that will be responsive to the needs of all motorists, rationalize traffic use of all thoroughfares, and help the efficient and safe flow of goods through the roads of the municipality.

**Section 2. Coverage.**— No cargo truck shall be allowed to travel or pass along Evangelista Road in Bacoor, Cavite from 5:00 A.M. to 9:00 A.M. and from 3:00 P.M. to 9:00 P.M. everyday except Saturdays, Sundays and Holidays.

**Section 3. Definition of Cargo Trucks.**— The term "cargo trucks" shall be understood to mean motor vehicles principally intended for carrying cargo and having license plates of the following classifications: "S", "T", "TC", "TH", "TRLB", "HNB", and "TRJ", to include other vehicles such as six-wheeler trucks, ten-wheeler trucks, lorries, vans, tankers, or other delivery vehicles, whether loaded or empty, having a gross capacity weight of more than 4,000 kilograms. *Provided*, that trucks owned and operated by the national government and its various instrumentalities including the municipal government, and/or privately-owned and operated trucks being leased by the municipal government are **exempted** from the coverage of this Ordinance.

**Section 4. Violation and Penalty.**— Any person who violates the provisions of this Ordinance shall be punished in the following manner:
