Page 2 Municipal Ordinance No. 5

WHEREAS, a review of the various fees indicated in Ordinance No. 4-S-99 conducted by Rural Health Physician, Dr. Encarnita J. Camama, revealed that the said fees need to be updated in view of the increase in the price of medicines and various medical supplies such as xray films, reagents, and the like;

WHEREAS, the charging of fees for the various health services is needed in order to make the Municipal Health Office self-sufficient;

WHEREAS, the funds derived from the fees to be imposed by the Municipal Health Office shall be used by the Municipal Government of Bacoor, Cavite to improve its health services and facilities and to cope with the growing demands for health care by the people of Bacoor, Cavite;

WHEREAS, in order to realize the above-mentioned objectives, it is of utmost necessity that health examination fees be imposed and that the pertinent provisions of Ordinance No. 4-S-99 be amended and repealed;

NOW, THEREFORE;

Be it ordained by the Sangguniang Bayan of Bacoor, Cavite in session assembled, that:

Section 1: This Ordinance shall be known as "*An Ordinance Prescribing Fees for Medical and Dental Examinations and Procedures Conducted by the Municipal Health Office of Bacoor, Cavite.*"

Section 2: The Municipality, through the Municipal Health Office, shall charge and collect the following fees for medical and dental examinations and procedures conducted by the Municipal Health Office, to wit:

Page 5 Municipal Ordinance No. 5

Section 4: *Exemptions.*-- All employees of the municipal government of Bacoor, Cavite as well as public school principals and teachers assigned at Bacoor, Cavite shall be exempt from the payment of the above-mentioned fees and charges.

Section 5: *Repealing clause.*-- All ordinances and executive orders previously passed or promulgated which are inconsistent with the foregoing shall be deemed repealed or modified accordingly.

Section 6: *Separability Clause.*-- Should any provision of this Ordinance be declared void by any court or tribunal, the provisions of this Ordinance not affected by the said declaration shall deemed valid.

Section 7: *Effectivity.*-- This Ordinance shall take effect fifteen (15) days after posting thereof in at least two (2) conspicuous places within the municipality of Bacoor, Cavite.
