Municipal Ordinance No. 95 Series of 2008

AN ORDINANCE GRANTING A DISCOUNT IN FAVOR OF DULLY-REGISTERED SENIOR CITIZENS OF BACOOR TO ADMISSION TICKETS IN CINEMAS OPERATING IN BACOOR CAVITE EVERY MONDAY AND THESDAY AND ALLOCATING PS00,000.00 FOR THE SAID PURPOSE TO BE TAKEN FROM THE BUDGET OF THE OFFICE OF SENIOR CITIZENS' AFFAIRS (OSCA).

WHEREAS, the municipality of Bacoor, Cavite desires to give additional privileges to its duly-registered senior citizens to make their lives more comfortable in their advanced age and in recognition of their valuable contributions to society;

WHEREAS, senior citizens of the municipality presently receive a 20% discount on cinema admission prices by virtue of the Senior Citizens Act;

NOW, THEREFORE:

Be it ordained by the Sangguniang Bayan of Bacoor, Cavite in special session assembled, upon motion of Councilor Bayani De Leon and duly approved by all the councilors present, that:

Title: This ordinance shall be known as the Section 1. "Bacoor Senior Citizen Cinema Discount Ordinance of 2008".


Scope: This ordinance shall only apply in cinemas Section 2. operating within Bacoor, Cavite and may only be availed of every Monday and Tuesday by senior citizens duly registered with the Office of Senior Citizens' Affairs (OSCA) of Bacoor, Cavite.

Aside from the 20% discount in Section 3. Discount cinema admission prices being received presently by senior citizens by virtue of the Senior Citizen's Act, all senior citizens duly-registered with the OSCA of Bacoor, Cavite shall also receive an additional 80% discount on the said cinema admission tickets every Monday and Tuesday courtesy of the municipal government of Bacoor, Cavite. Thus, citizens duly-registered with the OSCA of Bacoor, Cavite shall be allowed to watch movies in all cinemas operating in Bacoor, Cavite for free every Monday and Tuesday.

A senior citizen may only avail of the Section 4. Limitation above-mentioned discount in one movie per day.

Budget Allocation and Compensation: Section 5. compensate the various cinemas affected by this Ordinance, the amount of P500,000.00 shall be taken from the funds of the OSCA of Bacoor, Cavite and shall be used to pay the above-mentioned cinemas for the additional 80% discount to be granted to senior citizens covered by this Ordinance. Provided, that should the said amount be insufficient to compensate the said cinemas, the Municipal Mayor shall be allowed to draw additional funds to compensate the said cinemas subject to the Sangguniang Bayan.

Penalties: Cinemas found, after trib Section 6. proper court, to have violated this Ordinance shall be fined P2, 500.00 for every senior citizen covered by this Ordinance not given the aforementioned discount during the days covered by this Ordinance.

ensure the successful implementation and Policy Guidelines: To ensure the successful implementation of this Ordinance, the Office of the Municipal Mayor of Bacoor, Cavite is hereby authorized to draw up the necessary implementing rules and policy guidelines. Copies of the said implementing rules and policy guidelines shall be furnished to the management/operator of the cinemas affected by this Ordinance.

Section 8. Separability Clause: Should any provision of this Ordinance be declared void, the remaining provisions of this Ordinance not affected by the said declaration shall remain valid.

Section 9. Repealing Clause: All existing ordinances that are in conflict with this Ordinance are hereby repealed.

Section 10. Effectivity: This Ordinance shall take effect within fifteen days from its publication.
