MUNICIPAL ORDINANCE NO. 11
Series of 2009

"AN ORDINANCE CREATING THE MUNICIPAL REGISTRATION COMMITTEE PURSUANT TO SECTION 17 OF R.A. 7279 (URBAN DEVELOPMENT AND HOUSING ACT) AND PRESIDENTIAL PROCLAMATION NO. 397, SUBJECT TO ALL LEGAL AND EXISTING RULES AND PROCEDURES."

WHEREAS, Section 17 of R.A. 7279, otherwise known as the Urban Development and Housing Act (UDHA) and its Implementing Rules and Regulations and Presidential Proclamation 397 mandate the Local Government Units to undertake the Registration of Potential Socialized Housing Beneficiaries;

WHEREAS, the conduct of said registration is imperative to facilitate the implementation of the Urban Development and Housing Act towards the alleviation of the plight of our homeless and underprivileged constituents;

WHEREAS, the Municipality of Bacoor has no existing record of compliance to the Presidential Proclamation 397, and it is imperative to build the Masterlist to further implement a comprehensive program for potential socialized housing beneficiaries and set forth therein the mechanics of registration.

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF BACOOR, CAVITE UPON MOTION OF HON. BAYANI S. DE LEON UNANIMOUSLY SECONDED BY ALL THE MEMBERS PRESENT, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW IN SESSION ASSEMBLED, THAT:

Section 1. The Honorable Mayor, Strike B. Revilla, is hereby authorized to constitute the Municipal Registration Committee (MRC) and to appoint/designate the members thereof, with the understanding that the said Committee, once constituted, shall facilitate the creation of, and provide orientation for the Barangay Registration Committee (BRCs);

Section 2. Let copies of this Ordinance be sent to the Office of the Hon. Mayor for approval and execution, to the Urban Poor Planning and Housing Affairs Council for guidance and implementation and to the DILG and Presidential Commission for the Urban Poor (PCUP) for their information.
