**AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 25 SERIES OF 2009, AND FOR OTHER PURPOSES.**

*Sponsored by Councilor Reynaldo D.C. Palabrica*

Be it enacted by the Sangguniang Bayan of Bacoor, Cavite, in regular session held:

**WHEREAS**, the Municipality of Bacoor , Cavite passed Municipal Ordinance No. 25, Series of 2009 regulating the use of the municipal waters of Bacoor and defining its boundaries over which the said ordinance shall be strictly observed and applied.

**WHEREAS**, the municipal waters of Bacoor as defined in Section 3 of Municipal Ordinance No. 25-S-2009 was pursuant to the recommendation made by the National Mapping and Resource Information Authority (NAMRIA) with the agreement of the local governments of the Municipality of Kawit, Cavite and the City of Las Piñas.

**WHEREAS**, a new survey was conducted by the NAMRIA and it was discovered therein that there has been an error in the first survey it conducted thereby necessitating the amendment of the above-mentioned provision of Municipal Ordinance No. 25-S-2009.

**NOW, THEREFORE**, upon motion of Councilor Reynaldo D.C. Palabrica and duly seconded by Councilor Venus De Castro and Councilor Bayani De Leon, in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED**, that:

Section 1. The second paragraph of Section 3 of Ordinance No. 25, Series of 2009 is hereby amended to read as follows:
