AN ORDINANCE TRANSFERRING THE SITE OF THE LOCAL GOVERNMENT CENTER OF BACOOR, CAVITE.

WHEREAS, Section 11 (b) of Republic Act No. 7160 (also known as the "Local Government Code of 1991") provides that "when conditions and developments in the local government unit concerned have significantly changed subsequent to the establishment of the government, its sanggunian may, after public hearing and by virtue of a vote of two-thirds (2/3) of all its members, transfer the same to a site better suited to its needs."

WHEREAS, the present location of the municipal hall of Bacoor, Cavite no longer meet the needs of the municipality's burgeoning population and booming economy. Residents of the Molino area, where the bulk of Bacoor's population now resides, find the present location of the municipal hall too far away. On the other hand, businessmen and investors find the cramped office spaces at the municipal hall and the lack of ample parking space thereat inconvenient, thereby affecting the further growth of the local economy.

WHEREAS, the flashfloods caused by typhoon Ondoy that inundated the low-lying areas of Bacoor including the present site of the municipal government made municipal planners realize that the local government center of the municipality must be located at a site with a higher elevation and with many open spaces around it to make the same the ideal center for disaster response and relief operations of the municipal government.

NOW THEREFORE, upon the motion of Hon. Janairo San Miguel, in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** that:

Section 1. **Short Title.**-- This ordinance shall also be known as the "**Government Center Relocation Ordinance of Bacoor**".

Section 2. **Transfer of Local Government Center.** -- The site of the local government center of Bacoor, Cavite is hereby transferred to a lot with an area of 20,065 square meters, more or less, located at Barangay San Nicolas II more particularly described as follows:

Section 3. *Use of Old Local Government Center Site.* -- The present site of the local government center located at Evangelista Road, Barangay Poblacion, Bacoor, Cavite shall be used by the municipal government as a satellite office to serve the needs of its constituents residing nearby. Provided: that in case the said property shall be used for any other purpose or shall be leased out to any third party, the Office of the Mayor shall first obtain the permission of the Sangguniang Bayan before the said property can be used for such purpose or leased out to any third party.

Section 4. *Repealing Clause.* - Any provision of any ordinance, resolution, executive order, rules and regulations and/or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

Section 5. *Effectivity.* - This Ordinance shall take effect immediately upon its publication in a newspaper of general circulation which shall immediately follow its approval by the Sangguniang Panlalawigan.
