AN ORDINANCE CONCURRING IN THE APPOINTMENT OF ATTY. KHALID ATEGA JR. AS HUMAN RESOURCES MANAGEMENT V IN A CONCURRENT AND TEMPORARY CAPACITY.

WHEREAS, the Personnel Selection Board through its Resolution No. 001-2011 recommended the appointment of Atty. Khalid Atega Jr. as Human Resources Management Officer V at the newly created Human Resources Development and Management Department (HRDMD) considering that there are, as of now, no applicants to the said vacant position.

WHEREAS, in a letter dated 7 October 2011, the Municipal Mayor appointed Atty. Atega to the said position on the condition that the said appointment shall be concurrent and temporary in nature with no additional salaries or benefits.


WHEREAS, on 10 October 2011, the Honorable Mayor referred the said appointment to the Sangguniang Bayan for its concurrence and approval.


WHEREAS, Atty. Atega took no part in the deliberations of the council with regard the said matter.


Section 1. The Sangguniang Bayan concurs in the appointment of Atty. Khalid A. Atega Jr. as Human Resources Management Officer V of the Human Resources Development and Management Department (HRDMD) subject to the following conditions:


1. The said appointment shall only be temporary in nature which shall not exceed six (6) successive months subject to extension depending on the recommendation of the Local Chief Executive or the exigencies of public service;
2. Atty. Atega is hereby directed to concurrently exercise all the powers and responsibilities in his capacity as Secretary to the Sangguniang Bayan; and

However, he shall not be entitled to any additional salaries and benefits aside from the salaries and benefits he is currently receiving as Secretary to the Sangguniang Bayan.

Section 2. This ordinance shall take effect immediately after its posting in two (2) conspicuous places within the municipality. All ordinances, resolutions, executive orders, and memoranda contrary hereto are hereby repealed or amended accordingly.
