AN ORDINANCE REQUIRING THE INSTALLATION OF A "GREASE AND USED OIL WASTE DISPOSAL SYSTEM" IN ALL BUSINESS ESTABLISHMENTS OPERATING IN BACOOR, CAVITE.

WHEREAS, the unregulated dumping of untreated grease and used oil by various business establishments into the sewerage system of Bacoor greatly contributed to the deterioration of the municipality's various bodies of water.

WHEREAS, local government units are mandated by law to strictly implement the Clean Water Act.

WHEREAS, requiring the installation of a grease and used oil waste disposal system in all business establishments operating within Bacoor, Cavite will help return the various bodies of water within the municipality to its once pristine condition.

NOW, THEREFORE, upon motion of Councilor Jaime A. Sapanghila and unanimously seconded by all the members present of the Sangguniang Bayan in regular session assembled **BE IT ORDAINED AS IT IS HEREBY ORDAINED** that:

Sec. 1. Title.-- This Ordinance shall be known as the "**Grease Trap Ordinance of Bacoor**".

Sec. 2. Regulation.-- All business establishments operating within Bacoor, Cavite regardless of its nature are required to install a grease and used oil waste disposal system within their respective establishments before they can be allowed to operate. Provided: That all sari-sari stores operating within Bacoor, Cavite shall be exempted from the coverage of this Ordinance.

Sec. 3. Period of Compliance.-- All business establishments covered by this Ordinance shall be given three hundred sixty five (365) days from the date of effectivity hereof within which to comply herewith.


Sec. 4. Guidelines and Implementation.-- The implementing rules and guidelines of this Ordinance shall be drafted by the Office of the Municipal Mayor in consultation with experts on industrial design and environmental protection and with owners of various business establishments to be affected hereby.

The Business Permit and Licensing Office (BPLO) and the Office of the Building Official (OBO) of the municipality shall implement this Ordinance in conjunction with each other.

Sec. 5. *Information Campaign.*— The BPLO and the OBO shall start a massive information campaign regarding this Ordinance in conjunction with the Public Information Office (PIO) upon the date of effectivity of this Ordinance and shall continue three hundred sixty five (365) days hence. To this end, the said offices are hereby required to design the necessary information materials that will help in the effective implementation of this Ordinance subject to the approval of the Municipal Mayor.

Sec. 6. *Penalties.*— The following penalties shall be imposed against any violator of this Ordinance, to wit:

First Offense: Fine of One Thousand Pesos (PhP 1,000.00) to be paid by the owner/manager of the business establishment concerned.


Second Offense: Fine of One Thousand Five Hundred Pesos (PhP 1,500.00) to be paid by the owner/manager of the business establishment concerned.


Third Offense: Fine of Two Thousand Five Hundred Pesos (PhP 2,500.00) to be paid by the owner/manager of the business establishment concerned with closure of the said establishment until the responsible officers of the said establishment complies herewith.

Sec. 7. *Repeal.*— All ordinances, resolutions, executive orders, or guidelines in conflict herewith are hereby repealed and/or revised.


Sec. 8. *Effectivity.*— This Ordinance shall take effect within fifteen days after its approval by the Sangguniang Panlalawigan and after its publication in a newspaper of general circulation.






