MUNICIPAL ORDINANCE NO. 9
 Series of 2011

AN ORDINANCE MANDATING THE REGISTRATION OF ALL BICYCLES AND SIDECARS OPERATING IN BACOOR, CAVITE.

Sponsored by: Hon. Bayani M. De Leon

WHEREAS, the general welfare clause of the Local Government Code of 1991 empowers the Sangguniang Bayan to pass ordinances that will ensure public safety.

WHEREAS, the incidence of bicycle theft and accidents brought about by improperly constructed sidecars attached to bicycles or motorcycles are on the rise.

WHEREAS, the registration of bicycles and pedicabs that are attached to bicycles or motorcycles will help eliminate the problems mentioned above.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Bayan in regular session assembled to:

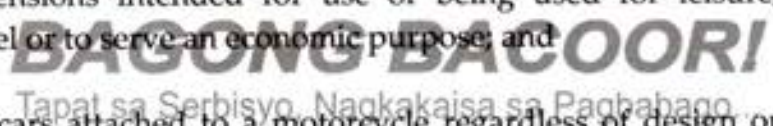
Section 1: This Ordinance shall be known as the "Bicycle and Pedicab Registration Ordinance of Bacoor".

Section 2: The following are covered by this ordinance and should be registered every year on or before the last day of March, to wit:

- a. Bicycles of whatever brand or type used by adults whether for leisure, travel, or to serve an economic purpose;
- b. Sidecars attached to a bicycle regardless of design or dimensions intended for use or being used for leisure, travel or to serve an economic purpose; and
- c. Sidecars attached to a motorcycle regardless of design or dimensions intended for use or being used for leisure, travel or to serve an economic purpose regardless of the make, model, or engine displacement of the motorcycle.

Section 3: A registration fee of One Hundred Fifty Pesos (P150.00) shall be charged against the owner/operator of a bicycle and/or sidecar covered by this ordinance. A registration fee of Fifty Pesos (P50.00) shall be charged to the owner of bicycles or sidecars covered by this ordinance for the renewal of the said registration.

Section 4. The Bacoor Transportation, Franchising and Fare Regulatory Board (BTFFRB) shall attach a registration plate with a unique and non-repeating registration number to every bicycle or sidecar that has been registered in compliance with this ordinance.

Section 5. PENALTIES. The Bacoor Traffic Management Office (BTMO) shall do the following within thirty (30) days after the approval of this ordinance by the Municipal Mayor.

5.1. Submit a design of the above-mentioned registration plate to the BTFFRB and to the Municipal Mayor which should be visible even at night and should be sturdy enough to resist the ravages of time, weather, and normal use;

5.2. Design the registration system/procedure to be used by the BTFFRB;

5.3 Submit the registration system/procedure to the BTFFRB and to the Municipal Mayor.

Section 6. The following penalties shall be imposed on anyone who violates this ordinance:

First Offense: community service consisting of street sweeping for three (3) continuous hours. The street/s to be swept shall be identified by the proper court of law.

Second Offense: community service consisting of street sweeping for five (5) continuous hours. The street/s to be swept shall be identified by the proper court of law.

Third Offense: **BAGONG BACOORI** confiscation of the bicycle or sidecar or both upon order of the proper court of law. Provided that the confiscated bicycle or sidecar shall only be returned after the owner thereof complies with this ordinance.

Section 7. Any provision of any ordinance, resolution, executive order, rules and regulations and/or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.
