AN ORDINANCE AUTHORIZING THE RELEASE OF FUNDS IN SUPPORT OF THE "AKSYON BARANGAY KONTRA DENGUE" (ABKD) PROGRAM OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT AND ENCOURAGING ALL BARANGAYS OF BACOOR, CAVITE TO SUPPORT THE SAID PROJECT .

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2012-16 on 30 January 2012 in response to the prevalence of dengue in various localities. It was through the said MC No. 2012-16 that "AKSYON BARANGAY KONTRA DENGUE" (ABKD) was created.

WHEREAS, the said program calls for the installation of the Ovicidal/Larvicidal Trap System (OL-Trap) to kill Aedes Mosquitoes in all barangays in order to reduce dengue cases and control the dengue transmission.

NOW, THEREFORE, upon motion of all the councilors present in regular session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Bayan to authorize the release of funds in support of the "AKSYON BARANGAY KONTRA DENGUE" (ABKD) Program of the Department of Interior and Local Government and encouraging all barangays of Bacoor, Cavite to support the said project.
