CITY ORDINANCE NO. 23
Series of 2012

AN ORDINANCE AUTHORIZING THE ESTABLISHMENT AND OPERATION OF THE "BACOOOR PUBLIC SERVICE DEVELOPMENT ACADEMY" AND PROVIDING FUNDS CONSISTENT HEREWITH.

WHEREAS, among the powers of the City Mayor as provided under Section 8 of Republic Act No. 10160 (otherwise known as the "Charter of the City of Bacoor") is to "present the program of government and propose policies and projects for the consideration of the Sangguniang Panlungsod at the opening of the regular session of the Sangguniang Panlungsod every calendar year and as often as may be deemed necessary as the general welfare of the inhabitants and the needs of the city government may require".

WHEREAS, Section 11, par. 5 (x) of RA 10160 empowered the Sangguniang Panlungsod to establish and provide for the operation of vocational and technical schools and similar post-secondary institutions and, with the approval of the Department of Education (DepEd) and subject to existing laws on tuition fees, fix and collect reasonable tuition fees and other school charges in educational institutions supported by the city government subject to the availability of funds and in conformity with existing laws, rules and regulations.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, submitted a position paper to the Sangguniang Panlungsod advocating the establishment of the *Bacoor Public Service Development Academy* which, as he envisions, will provide "high quality, relevant, responsive, effective, and affordable training and education to public servants in the City of Bacoor and other local government units in the Philippines".

Section 1. The City Mayor is hereby authorized to proceed with the establishment, organization, and operation of the proposed learning institution to be operated and established by the City Government known as the "Bacoor Public Service Development Academy" ("BPSDA" for brevity).

Section 2. The City Government and the City Mayor is hereby authorized to convert in whole or in part, the four-storey edifice being presently used as the government center located at Barangay TabingDagat, Poblacion, City of Bacoor, Cavite into the main building of the BPSDA subject to pertinent provisions of all laws and government regulations. Provided, that such conversion shall only take place after the new government center located at Barangay Bayanan, City of Bacoor, Cavite has already been completed and is already fully operational.

Section 3. An initial funding of Two Million Pesos (PhP 2,000,000.00) to be taken from any of the unappropriated funds of the City Government is hereby appropriated for the rehabilitation, repair, and renovation of the present seat of office of the City Government of Bacoor, Cavite. Provided, that if there are no available funds to give effect to the foregoing, the said funds shall be appropriated in the annual budget of the City Government for 2013 subject to the limitations of all pertinent laws and government regulations.

Section 4. The City Mayor is hereby authorized to appoint any department head of the City Government to temporarily act as administrator of the BPSDA until a person qualified for the said position has been appointed.

Section 5. The City Mayor is further authorized to form an *ad hoc* committee that will (a) determine the powers, functions, and qualifications of the BPSDA Administrator, (b) design the operating policy manual of the BPSDA; and (c) recommend to the City Mayor and to the Sangguniang Panlungsod the manner by which the said institution shall be funded.

Section 6. The City Mayor is hereby authorized to sign any agreement or contract with the duly authorized representatives of the TESDA, DAP, and LGA the provisions of which should be consistent with the instant Ordinance and all pertinent laws and regulations of the Republic of the Philippines.

BAGONG BACOOR!

Section 7. Should any provision hereof be declared void by any competent court of law, the other provisions of this Ordinance that are not affected thereby shall retain their legal force and effect.

Section 8. This Ordinance shall take effect fifteen (15) days after its approval by the Sangguniang Panlalawigan and after its posting in at least two conspicuous places within the Province of Cavite.


