AN ORDINANCE AMENDING THE LYRICS OF "HIMNO NG BACOOR".

WHEREAS, on 5 November 2007, the Sangguniang Bayan passed Resolution No. 40B-S-2007 approving the lyrics of the "Himno ng Bacoor" and mandating that it be sung in all government buildings and offices within the municipality of Bacoor;

WHEREAS, there is a need to revise the lyrics of the "Himno ng Bacoor" in view of the conversion of Bacoor into a city pursuant to Republic Act No. 10160;
