A CITY ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 5, SERIES OF 2011, ENTITLED, "AN ORDINANCE REQUIRING THE INSTALLATION OF A "GREASE AND USED OIL WASTE DISPOSAL SYSTEM" IN ALL BUSINESS ESTABLISHMENTS OPERATING IN BACOR, CAVITE".

WHEREAS, there is a need to amend pertinent provisions of various municipal ordinances such as Municipal Ordinance No. 5-S-2011 pursuant to the ratification of Republic Act No. 10160 on June 23, 2012 converting Bacoor into a component city of Cavite;

NOW, THEREFORE, during regular session assembled, upon motion of Councilor Reynaldo D. Palabrica unanimously seconded by all the councilors in regular session assembled **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to amend various sections of this Ordinance to read as follows, to wit:

Section 1. The following provisions of Municipal Ordinance No. 5-S-2011 are hereby amended and shall henceforth read as follows:

"Sec. 1. Title.-- This Ordinance shall be known as the "**Grease Trap Ordinance of the City of Bacoor**".

Sec. 2. Regulation.-- All business **and commercial** establishments operating within **the City of Bacoor**, Cavite regardless of its nature are required to install a grease and used oil waste disposal system within their respective establishments before they can be allowed to operate. Provided: That all sari-sari stores operating within **the City** of Bacoor, Cavite shall be exempted from the coverage of this Ordinance.

Sec. 6. Penalties.-- The following penalties shall be imposed against any violator of this Ordinance, to wit:

First Offense: Fine of **One Thousand Five Hundred Pesos (PhP 1,500.00)** to be paid by the owner/manager of the business **or commercial** establishment concerned.

Second Offense: Fine of **Two Thousand Pesos (PhP 2,000.00)** to be paid by the owner/manager of the business **or commercial** establishment concerned.

Third Offense: Fine of **Three Thousand Pesos (PhP 3,000.00)** to be paid by the owner/manager of the business **or commercial** establishment concerned with closure of the said establishment until the responsible officers of the said establishment complies herewith".

Section 2. Separability. Should any provision of this Ordinance be declared void or unconstitutional, all other
