**WHEREAS**, there is a need to amend pertinent provisions of various municipal ordinances such as Municipal Ordinance No. 11-S-2011 pursuant to the ratification of Republic Act No. 10160 converting Bacoor into a component city of Cavite;

**NOW, THEREFORE**, during regular session assembled, upon motion of Councilor Robert R. Javier unanimously seconded by all the Councilors present, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to amend various section of this Ordinance to read as follows, to wit:

**Section 1.** The following provisions of Municipal Ordinance No. 11, Series of 2008 are hereby amended and shall read as follows:

"Section 1. Title : This Ordinance shall be known as the "2013 Free Cinema Admission Ordinance for the Disabled Citizens of Bacoor".

Section 2. Scope : This ordinance shall only apply to cinemas operating within the City of Bacoor, Cavite and shall only apply to persons with disabilities.

Section 3. Person with disabilities residing at the city of Bacoor, Cavite shall be entitled to free admission to all cinemas within Bacoor, Cavite which only be availed every Monday and Tuesday for the exclusive use or enjoyment of persons with disability, provided that this privilege may only be availed of once every Monday or Tuesday and only by the person with disability.

The above-mentioned privilege is available only to persons with disability who are permanent residents of Bacoor, Cavite upon submission of an identification card issued by the City Mayor.

Section 4. Budget Allocation and Compensation : To compensate the establishments affected by this Ordinance, the amount of Php 500,000.00 shall be taken from the city funds of Bacoor, Cavite. Should the said amount be insufficient to compensate to the establishments, the City Mayor shall be allowed to draw additional funds subject to the appropriation of the Sangguniang Panlungsod.

Section 5. Penalties : Establishments found, after trial by the proper court, to have violated this Ordinance shall be fined Php 5,000.00 for every disabled citizen covered by this Ordinance not given the aforementioned discount during the days covered by this Ordinance.

**Section 6. Implementation and Policy Guidelines :** To ensure the successful implementation of this Ordinance, the Office of the City Mayor of Bacoor, Cavite is hereby authorized to draw up the necessary implementing rules and policy guidelines. Copies of the said implementing rules and policy guidelines shall be furnished to the management/operator of the establishments affected by this Ordinance."

**Section 2. Separability Clause---**Any provision of this Ordinance found void by a court of competent jurisdiction shall not affect the rest of this Ordinance not affected by the said judicial finding of invalidity.

**Section 3. Effectively---**This Ordinance shall take effect immediately after it has been posted in at least three (3) conspicuous places within the City of Bacoor, Cavite.

**Section 4. Repealing Clause---**Any ordinance in conflict with this Ordinance is hereby repealed and/or modified.
