AN ORDINANCE RE-ALIGNING THE AMOUNT OF ONE MILLION ONE HUNDRED THOUSAND PESOS (PHP 1,100,000.00) FROM "OTHER MAINTENANCE AND OPERATING EXPENSES" FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANT EXPENSES" UNDER THE BUDGET OF THE OFFICE OF THE CITY VICE MAYOR ; AND RE-ALIGNING THE AMOUNT OF ONE MILLION PESOS (PHP1,000,000.00) FROM "OTHER MAINTENANCE AND OPERATING EXPENSES" FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "GASOLINE, OIL AND LUBRICANT EXPENSES" UNDER THE BUDGET OF THE OFFICE OF THE SANGGUNIANG PANLUNGSOD FROM THE CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2013.
