**A CITY ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 25, SERIES OF 2011, ENTITLED, "AN ORDINANCE REQUIRING STREET VENDORS AND AMBULANT VENDORS TO BRING OR PROVIDE TRASH RECEPTACLES AT THEIR PLACE/S OF BUSINESS".**

No. 25-S-2011 pursuant to the ratification of Republic Act No. 10160 on June 23, 2012 converting Bacoor into a component city of Cavite;

**NOW, THEREFORE**, during regular session assembled, upon motion of Councilor Leandro A. De Leon duly seconded by Councilor Gaudencio P. Nolasco **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to amend various sections of this Ordinance to read as follows, to wit:

**Section 1.** The following provisions of Municipal Ordinance No. 25-S-2011 are hereby amended and shall henceforth read as follows:

"Section 1. Title.- This ordinance shall also be known as the **"Ambulant Vendors' Trash Bin Ordinance of the City of Bacoor"**."

**Section 2. Coverage.**— All street vendors and ambulant vendors operating within the jurisdiction of the **City of Bacoor** are covered by this ordinance.

**Section 5. Penalties** - the following penalties shall be imposed against any street vendor or ambulant vendor who violates this Ordinance:

First offense: Fine of **Seven Hundred Pesos (P700.00)**

Second offense: Fine of **One Thousand Seven Hundred Pesos (P1,700.00)**.

Third offense: Fine of **Three Thousand Pesos (P3,000.00)** plus imprisonment of not more than two (2) months.

**Section 6. Implementing Guidelines.**— The **Office of the City Mayor** shall draft the implementing guidelines for this Ordinance. The said implementing guidelines shall be published in a newspaper of general circulation operating in Cavite".

**Section 2.** Repealing Clause. – Any provision of any ordinance, resolution, executive order, rules and regulations and/or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed.

**Section 3.** Separability. – The unconstitutionality or invalidity of a particular provision of this Ordinance shall not affect the validity and enforceability of the remaining provisions hereof.
