**AN ORDINANCE RE-ALIGNING THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (PHP 150,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES" FOR THE PAYMENT OF EXPENSES TO BE INCURRED UNDER "INTERNET EXPENSES" UNDER THE BUDGET OF THE SANGGUNIANG PANLUNGSOD, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2013.**

WHEREAS, submitted for review and approval is the proposed re-alignment of funds under "Other Maintenance and Operating Expenses" to "Internet Expenses" in the Office of the Sangguniang Panlungsod covered by the Annual Budget for Calendar Year 2013. The said proposed re-alignment shall be used in the creation of the website of the Sangguniang Panlungsod in line with its "Paperless Deliberation Program" and transparency agenda.

NOW THEREFORE, upon motion of Councilor Reynaldo Palabrica unanimously seconded by all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the re-alignment of funds under the Sangguniang Panlungsod's budget for "Other Maintenance and Operating Expenses" to "Internet Expenses" as indicated above covered by Annual Budget for CY 2013.

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that :

Section 1. The purpose of this Ordinance is to appropriate the amount of One Hundred Fifty Thousand Pesos (PhP 150,000.00) for the "Internet Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2013;

Section 2. The above-mentioned amount of One Hundred Fifty Thousand Pesos (PhP 150,000.00) shall be re-aligned from the "Other Maintenance and Operating Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2013;

Section 3. The purpose of the said re-alignment is to finance the construction of the internet website of the Sangguniang Panlungsod in line with its "Paperless Deliberation Program" and its transparency agenda.

Section 4. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 5. This Appropriation Ordinance shall take effect upon its approval.
