NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in regular session duly assembled **THAT**:

Section 1. The newly constructed public elementary school at Malipay Phase 3, Molino 4, Bacoor City, Cavite is hereby officially named, as per the recommendation of the Local School Board, as the "Revilla Elementary School" in honor of the Revilla family which has consistently championed the interests of the people of the City of Bacoor and of the Province of Cavite.

Section 2. All ordinances, rules and regulations, or parts thereof, in conflict with, or is inconsistent with any of this Code are hereby repealed or modified accordingly.

Section 3. This Ordinance shall become effective upon completion of its posting in at least (3) three conspicuous places in the City of Bacoor, Cavite pursuant to Sections 59 and 188 of R.A. 7160, the Local Government Code of 1991.
