AN ORDINANCE ESTABLISHING THE CELEBRATION OF "BIBLE WEEK" EVERY LAST WEEK OF JANUARY WITHIN THE CITY OF BACOR.

WHEREAS, the officials of the Bacoor City Chaplains formally petitioned the Sangguniang Panlungsod to pass an ordinance mandating the celebration of "Bible Week" every last week of January within the City of Bacoor;

Section 3. This Ordinance shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulleting board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.
