2. Panapaan VIII – Three Million Five Hundred Eighty Two Thousand Nine Hundred Twenty Two Pesos (Php3,582,922.00) (Please see attached Barangay Resolution No. 01-14 and Appropriation Ordinance No. 1 dated February 4, 2014)
3. Habay II – Six Million Four Hundred Nineteen Thousand Five Hundred Eighty Eight Pesos (Php6,419,588.00) (Please see attached Barangay Resolution No. 001 and Appropriation Ordinance No. 1 dated January 8, 2014);
4. Digman – One Million Five Hundred Nine Thousand Fifty Pesos (Php 1,509,050.00) (Please see attached Barangay Resolution No. 01-14 and Appropriation Ordinance No. 1 dated February 5, 2014);
