3. Salinas I – Eight Hundred Five Thousand Four Hundred Thirty One Pesos and 70/100 ( Php 805,431.70)( Please see attached Barangay Resolution No.18-2014 Series of 2014 and Appropriation Ordinance No. 02-2014 Series of 2014).
