A CITY ORDINANCE REQUIRING BIDDERS FOR CONTRACTS WITH THE CITY OF BACOR TO SECURE BUSINESS PERMITS FROM THE FORMER.

WHEREAS, a significant number of bidders and contractors engaging in business transactions with the City Government of Bacoor, Cavite are not based in the latter's territorial jurisdiction;

WHEREAS, there is inherent difficulty verifying the background and financial status of these entrepreneurs during bidding due to time constraints. Moreover, it is not far-fetched to assume that some bidders or contractors may have shady characters out to defraud the government.

WHEREAS, prudence dictates the need to verify the legal papers of entrepreneur doing business with the city;

WHEREAS, in order to free the City of undesirable businessmen transacting business with it, there is a need to impose a preventive/protective mechanism in the manner of requiring the submission of legal documents to the City through the issuance of permits;

WHEREAS, since these business entities clearly derive benefit from the activities and contracts with the City Government it is but fair and equitable that they be likewise required to secure a business permit from the Bacoor City Government;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod, in regular session duly assembled; **THAT:**

Section 1. Title. - This Ordinance shall also be known as the **"Business Permit For Contractors Ordinance."**

Section 2. Requirement. - All natural or juridical entities such as corporations, partnerships, and sole proprietorships that would participate in any bidding for any contract with the City of Bacoor or with any of its department or units are henceforth required to secure a business permit with the Business Permits and Licensing Office (BPLO) of the City of Bacoor before allowing it to participate in such bidding or to do business with City Government.

Section 3. Additional BAC Requirement - The Bids and Awards Committee (BAC) of the City Government of Bacoor, Cavite shall require such business permit as part of the documents every prospective bidder has to submit for the eligibility check to ensure that this ordinance is faithfully adhered to.

Section 4. Separability Clause. - If for any reason, any provision, section, or part of this Ordinance is declared not valid by a court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections, or parts which shall continue to be in force and effect.

Section 5. Repealing Clause. - All ordinances, rules and regulations, or parts thereof, in conflict with, or is inconsistent with any of this Ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity. - This ordinance shall take effect upon its posting in at least three (3) conspicuous places within the City of Bacoor and upon publication at least once in a newspaper of general circulation.
