**AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF MAMBOG II AMOUNTING TO FOUR HUNDRED THIRTY NINE THOUSAND ONE HUNDRED SEVENTY TWO PESOS AND 67/100 (Php 439,172.67) AND BARANGAY REAL II AMOUNTING TO FIFTY SIX THOUSAND SIX HUNDRED FIVE PESOS AND 65/100 (Php 56,605.65).**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Mambog II – Four Hundred Thirty Nine Thousand One Hundred Seventy Two Pesos and 67/100 (Php 439,172.67) (Please see attached Barangay Resolution No. 02-2014 Series of 2014 and Appropriation Ordinance No. 02 -2014 Series of 2014 dated July 04, 2014); and
2. Real II– Fifty Six Thousand Six Hundred Five Pesos and 65/100 (Php 56,605.65) (Please see attached Barangay Resolution No. 03 Series of 2014 and Appropriation Ordinance No. 02 Series of 2014 dated August 30, 2014).

**WHEREFORE,** after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its 54<sup>th</sup> regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED,** to approve the Supplemental Appropriation of Barangay Mambog II and Real II provided that the above-mentioned budgets complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED FURTHER,** to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.

**ORDAINED LASTLY,** that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
