**AN ORDINANCE CREATING VARIOUS POSITIONS AND CORRECTING VARIOUS POSITION TITLES UNDER THE OFFICE OF THE CITY MAYOR AND THE OFFICE OF THE SANGGUNIANG PANLUNGSOD AND PROVIDING FUNDS THEREFORE.**

**WHEREAS**, Section 11, paragraph 1, sub-paragraphs vii and viii of Republic Act No.10160 (also known as "the Charter of the City of Bacoor") empowers the Sangguniang Panlungsod to:

"vii) Subject to the provisions of the Local Government Code of 1991 and other pertinent laws, determine the powers and duties of officials and employees of the City;

(viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government;"

**WHEREAS**, the Sangguniang Panlungsod unanimously approved City Resolution No. CR 2014-59 expressing the sentiment of the city council to create the position of either a Public Information Officer or Media Relations Officer under the Office of the Sangguniang Panlungsod to help widen the dissemination of news related to the achievements and programs of the Sangguniang Panlungsod and of the City Vice Mayor;

**WHEREAS**, the Human Resources and Development Management Department (HRDMD) requested the Sangguniang Panlungsod to correct the parenthetical titles of the Head of the HRDMD Head and that of the Head of the Office of the Building Official.

**WHEREAS**, the Civil Service Commission (CSC) through Atty. Judith A. Dongallo-Chicano (Director IV) issued an Order dated 1 July 2014 recommending the revocation/invalidation of the permanent appointment of Atty. Roy E. Cheng and Atty. Maria Melissa G. Torres (Legal Officer III/SG 20) of the city government due to the "re-

**Section 3. Funding.** -- The funds necessary to pay the salaries of the newly created positions shall be taken from the available funds of the Office of the City Mayor and of the Office of the City Vice Mayor in the annual budget.

**Section 4. CSC approval.** -- The Human Resources Development and Management Department (HRDMD) of the city government is hereby directed to undertake such steps as to ensure the approval of this ordinance, and of the offices created hereunder, by the Civil Service Commission as early as possible.

**Section 5. Separability Clause.** -- If for any reason, any provision, section, or part of this Ordinance is declared not valid by a court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections, or parts which shall continue to be in force and effect.

**Section 6. Repealing Clause.** -- All ordinances, rules and regulations, or parts thereof, in conflict with, or is inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

**Section 7. Effectivity.** -- This Ordinance shall become effective upon completion of its posting in at least (3) three
