**CITY ORDINANCE NO. CO 35-2014**  
 Series of 2014

**AN ORDINANCE AUTHORIZING AND DIRECTING ATTY. KHALID A. ATEGA, JR., SANGGUNIANG PANLUNGSOD SECRETARY OF THE CITY OF BACOR, TO BE APPOINTED AS THE SECOND MEMBER OF THE BACOR CITY TRANSPORTATION AND FRANCHISING BOARD.**

**WHEREAS,** the City Transportation and Franchising Board (the "Board") was created by virtue of Section 27 of City Ordinance No. 2013-047 (otherwise known as the "Traffic Code of the City of Bacoor").

**WHEREAS,** under Section 28 of the Traffic Code, the Board shall be comprised of the following members:

**"Section 28. Composition/Term of Office.** - The BCTFB shall be composed of six (6) members. Provided that, for purposes of continuity and to preserve the independence of the Board, the terms of office of the first five members of the Board shall be as follows:

First Member	Three (3) years
Second Member	Two (2) years
Third Member	One (1) year
Fourth Member	One (1) year
Fifth Member	One (1) year
Sixth Member	Three (3) years or remainder of one term

Provided, lastly, that the terms of office of the members who will be appointed after the terms of office of the first set of members shall not exceed three (3) years. Any interruption in the terms of office of any member of the BCTFB shall empower the City Mayor to appoint a replacement, provided, however, that the newly-appointed member should only serve the remainder of the term of the member he replaced."

**WHEREAS**, after a series of deliberations in close consultation with the City Mayor, Hon. Strike B. Revilla, the Sangguniang Panlungsod unanimously decided to authorize the appointment of **ATTY. KHALID A. ATEGA, JR.**, Sangguniang Panlungsod Secretary, as the Second Member of the Board in view of his qualifications and sterling public service record.

**NOW, THEREFORE**, upon unanimous motion of the members of the Sangguniang Panlungsod of the City of Bacoor in regular session assembled, it is hereby ordained **THAT**:

Section 1. The Sangguniang Panlungsod unanimously authorizes the appointment of Atty. Khalid A. Atega, Jr. as Vice-Chairperson of the City Transportation and Franchising Board (the "Board"), perform the functions and exercise the powers of the said position as enumerated under City Ordinance No. 2013-47 and its implementing guidelines and shall be entitled to receive any additional emoluments or benefits related to his appointment to the said post.

Section 2. Notwithstanding his appointment mentioned above, Atty. Atega shall be directed and required to report the various programs and actions of the Board to the Sangguniang Panlungsod at least once every two (2) months or whenever the need to make such a report arises.

Section 3. As a consequence of his appointment, Atty. Atega shall be directed and required to report the various programs and actions of the Board to the Sangguniang Panlungsod at least once every two (2) months or whenever the need to make such a report arises.

Section 4. Atty. Atega is expected to ensure that all the powers bestowed by the Sangguniang Panlungsod to the Board are conscientiously and consistently performed by the latter.

Section 5. The appointment of Atty. Atega as Vice-Chairperson of the Board shall only be for two (2) years unless renewed by the City Mayor.

Section 6. This Ordinance shall take effect immediately upon its publication at least once in a newspaper of general circulation within the Province of Cavite and after it has been posted on three conspicuous places within the City of Bacoor.

Section 7. In case his appointment to the Board is later disapproved either by the Civil Service Commission (CSC) or by any court, agency, or office with the legal authority to do so, any additional benefit or emoluments received by Atty. Atega for services already rendered shall not be forfeited in favor of the city government.

Section 8. The composition of the Board is hereby amended so that it shall have a Seventh Member who shall be an incumbent

member of the Sangguniang Panlungsod of Bacoor City, Cavite who shall also be appointed by a majority of the member of the city council along with the Sixth Member. Section 29 of City Ordinance No. 2013-02 ("The Revised Traffic Code of the City of Bacoor") is hereby amended.

Section 9. All ordinances, resolutions, or executive orders contrary to or in conflict with the provisions of this Ordinance are hereby repealed, revoked, or amended accordingly.

Section 10. The declaration of any provision of this Ordinance as void or unconstitutional by any competent court of law shall not affect the validity or enforceability of the rest of this measure.
