AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOR.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

4. Zapote III – One Hundred Forty Five Thousand Three Hundred Sixty Nine Pesos and 02/100 (Php 145,369.02) (Please see attached Barangay Resolution No. 02-2014 Series of 2014 and Appropriation Ordinance No. 2 -2014 Series of 2014 dated October 23, 2014);
5. Salinas III – One Hundred Thirty Two Thousand Two Hundred Seventy Eight Pesos and 30/100 (Php 132,278.30) (Please see attached Barangay Resolution No. 02-2014 Series of 2014 and Appropriation Ordinance No. 02-2014 Series of 2014 dated October 23, 2014).
