AN ORDINANCE RE-ALIGNING THE AMOUNT OF TWO MILLION SEVEN HUNDRED THIRTY SEVEN THOUSAND PESOS (PHP 2,737,000.00) FROM THE "TRAINING EXPENSES" AND "OTHER MAINTENANCE AND OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "GASOLINE, OIL AND LUBRICANTS EXPENSES", "ADVERTISING EXPENSES", AND "OFFICE SUPPLIES EXPENSES" UNDER THE BUDGET OF THE SANGGUNIANG PANLUNGSOD OFFICE; AND RE-ALIGNING THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) FROM THE "TRAINING EXPENSES" AND "OTHER MAINTENANCE AND OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "GASOLINE, OIL AND LUBRICANTS EXPENSES" UNDER THE BUDGET OF THE VICE MAYOR'S OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2014.

WHEREAS, the funds to be re-aligned shall no longer be used by the Office of the Sangguniang Panlungsod and the Vice Mayor's Office for the "Other Maintenance and Operating Expenses" and "Training Expenses" considering that there are sufficient available funds to finance the operating expenses of the said offices;

WHEREAS, there is a need to re-align the amount of Two Million Seven Hundred Thirty Seven Thousand Pesos (PhP2,737,000.00) from the "Other Maintenance and Operating Expenses" and "Training Expenses" to the "Gasoline, Oil and Lubricants Expenses", "Advertising Expenses", and "Office Supplies Expenses" under the Office of the Sangguniang Panlungsod; and to re-align the amount of One Million Five Hundred Thousand Pesos (PhP1,500,000.00) from the "Other Maintenance and Operating Expenses" and "Training Expenses" to the "Gasoline, Oil and Lubricants Expenses" under the Office of the Vice Mayor, to wit:
