**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOR.**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

4. Molino VII – Four Hundred Three Thousand Seven Hundred Twenty Five Pesos and 37/100 ( Php 403,725.37) (Please see attached Barangay Resolution No. 03-2014 Series of 2014 and Appropriation Ordinance No. 02 -2014 Series of 2014 dated November 3, 2014);
