AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF BARANGAY DULONG BAYAN AMOUNTING TO THREE MILLION SEVEN HUNDRED NINETY SEVEN THOUSAND ONE HUNDRED FIVE PESOS (Php 3,797,105.00) IN THE CITY OF BACODR.
