AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOR.

2. Ligas I – Three Hundred Twenty Five Thousand Six Hundred Twenty Two Pesos and 64/100 (Php 325,622.64) (Please see attached Barangay Resolution No. 02-2014 Series of 2014 and Appropriation Ordinance No. 02-2014 Series of 2014 dated November 11, 2014

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its 66th regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Talaba VI and Ligas I provided that the above-mentioned budgets complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
